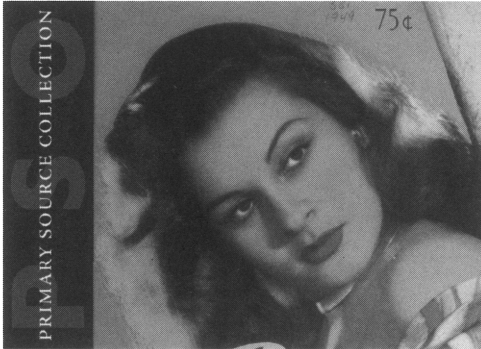

From the archives of the Filmoteca de la UNAM in Mexico City comes this unique collection of cinematographic documents from the “Golden Age” of Mexican cinema (1930-1960). Not only does the collection consist of contemporary periodicals such as *Cinema Reporter* and *Cine Mundial*, it also includes dozens of film flyers that were handed out in the streets to lure people into the cinema. Finally, the collection gives access to the personal scrapbook of Fernando de Fuentes, a pioneering director and one of the most important Latin American filmmakers to this day. Heretofore only accessible in the Filmoteca de la Unam, these sources will provide ample material for research to Latin American media and culture, and for studies to the political, historical and social impact of cinema.
