

## NOTES ON CONTRIBUTORS

**Ana Antic** is a lecturer in modern European history at the University of Exeter. She is the author of *Therapeutic Fascism: Experiencing the Violence of the Nazi New Order* (Oxford, 2017). She has published a variety of articles on the history of violence, psychiatry and Eastern Europe which have appeared in *European History Quarterly*, *History of Psychiatry*, *Journal of Social History*, *Social History of Medicine* and *Contemporary European History*, among others.

**Holly Groot** is an associate professor of history at the University of Alabama and currently writing a history of celebrity in fin-de-siècle France. She is author of *The Force of Beauty: Transforming French Ideas of Femininity in the Third Republic* (Baton Rouge, 2015). She has published an article on beauty pageants in *French Politics, Culture and Society* and has an article on the French showgirl Mistinguett forthcoming in *French Historical Studies*.

**Ana Isabel Keilson** is an intellectual historian of modern Europe and a lecturer in social studies at Harvard University. She is currently writing a book on culture, politics and modern dance in Germany, 1900–35.

**Katherine Lebow** teaches European and global history at the University of Oxford. Her first book, *Unfinished Utopia: Nowa Huta, Stalinism, and Polish Society, 1949–56* (Cornell, 2013), won the Barbara Jelavich Prize of the Association for Slavic, East European and Eurasian Studies. Her current research focuses on autobiography, testimony and transatlantic social science ca. 1914–50.

**Małgorzata Mazurek** is an associate professor of Polish studies at Columbia University. Her current book project explores the intellectual history of East Central European involvement in the making of the non-Western world ca. 1920–60. She is also a member of the international research project *Socialism Goes Global: Cold War Connections Between the ‘Second’ and ‘Third World’ 1945–1991*. She is the author of *Socialist Factory: Workers in People’s Poland and in the GDR on the Eve of the Sixties* (Warsaw, 2005) and *Society in Waiting Lines: On Experiences of Shortages in Postwar Poland* (Warsaw, 2010).

**Raluca Muşat** is an unaffiliated researcher. She has previously taught at University College London, Goldsmiths, University of London and St. Mary’s University. Her research interests include the history of the social sciences, the history of rural development and everyday life in Eastern Europe under communist rule.


**Sara Silverstein** is an assistant professor of history and human rights at the University of Connecticut. Silverstein received her PhD in history from Yale University in 2016. She is working on a book manuscript titled *Doctors as Diplomats: The Origins of Universal Healthcare in International Society*.

**Quinn Slobodian** is ACLS Burkhardt Fellow at Harvard University’s Weatherhead Initiative on Global History and an associate professor of history at Wellesley College. His most recent book is *Globalists: The End of Empire and the Birth of Neoliberalism* (Harvard, 2018).

**Joanna Wawrzyniak** is a sociologist and historian at the University of Warsaw. Currently, she is leading an ECHOES project on ‘City Museums and Multiple Colonial Pasts’. She was previously a visiting fellow at the European University Institute, the New School for Social Research, the

Freiburg Institute for Advanced Studies, the Imre Kertész Kolleg Jena and the Herder Institute in Marburg. She has co-edited *Memory and Change in Europe: Eastern Perspectives* (New York, 2016) and co-authored *Enemy on Display: The Second World War in Eastern European Museums* (New York, 2015).

**Daniel Zamora** Vargas is a post-doctoral sociologist (FNRS) at the Group for Research on Ethnic Relations, Migration & Equality (GERME) at the Université Libre de Bruxelles and at the University of Cambridge (Wiener-Anspach Fellow). He works on the history of poverty, and inequality, as well as on modern intellectual history. His current research is about the history of basic income in a global perspective.

## NOTES FOR CONTRIBUTORS

*Contemporary European History* covers the history of Eastern and Western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

### Submissions

Authors wishing to submit articles for publication should do so through the journal's online submissions system at <http://mc.manuscriptcentral.com/conteurohistory>.

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers will be expected to submit a final version which should include

1. the text, which should begin with the title, the author's name and email and postal address and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short biographical note with a description of work in progress and previously published work (130 words max.)
