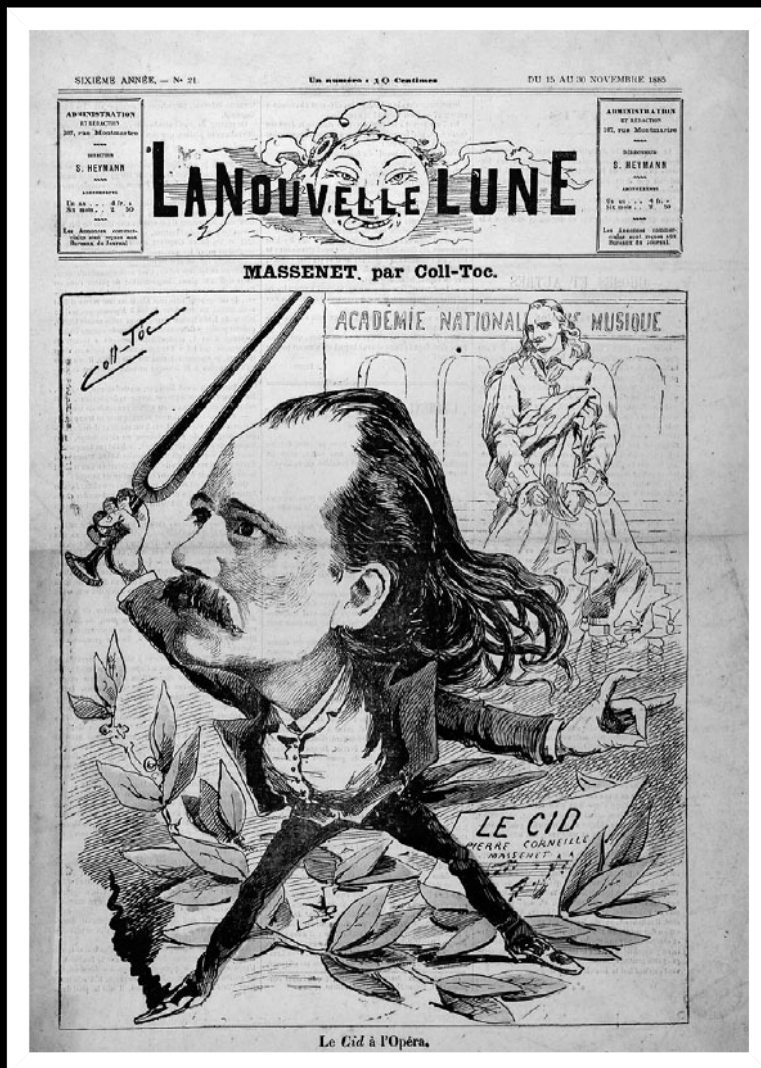

CONTRIBUTORS

Carlo Cenciarelli is a British Academy Postdoctoral Fellow at Royal Holloway, University of London. His research revolves around the intersection between music and visual culture in the twentieth and early twenty-first centuries, with a particular focus on practices of cultural borrowing, the history of technology and the afterlife of Western art music. He has published in journals including *Twentieth-Century Music*, the *Journal of the Royal Musical Association* and *Music & Letters*.

Katharine Ellis is Stanley Hugh Badock Professor of Music at the University of Bristol. She is widely published on the social and cultural history of music including *Music Criticism in Nineteenth-Century France* (Cambridge University Press, 1995), *Interpreting the Musical Past: Early Music in Nineteenth-Century France* (2005) and *The Politics of Plainchant in 'fin-de-siècle' France* (2013). A former editor of *Music & Letters* and the *Journal of the Royal Musical Association*, she was elected to the Academia Europaea in 2010.

Roberta Montemorra Marvin, co-editor of this issue, has published widely on Italian opera of the nineteenth century. She is co-editor of several books, most recently *Music in Print and Beyond: Hildegard von Bingen to The Beatles* (with Craig A. Monson, 2013) and *Fashions and Legacies of Nineteenth-Century Italian Opera* (with Hilary Poriss, Cambridge University Press, 2010), and author of *Verdi the Student – Verdi the Teacher* (2010, winner of the Premio Internazionale 'Giuseppe Verdi'). *The Cambridge Verdi Encyclopedia*, for which she serves as editor, is forthcoming in 2013.

Cormac Newark is Senior Lecturer in Music at the University of Ulster. He works mainly on nineteenth-century French and Italian opera and literature and has published articles in *19th-Century Music*, *Cambridge Opera Journal* and *Journal of the Royal Musical Association*, and essays in various collected volumes. He is the author of *Opera in the Novel from Balzac to Proust* (Cambridge University Press, 2011).

Clair Rowden is Lecturer in the School of Music at Cardiff University. Her research deals with opera, dance, iconography and nineteenth-century France; publications include *Republican Morality and Catholic Tradition at the Opera: Massenet's 'Hérodiade' and 'Thaïs'* (2004) and an edited volume *Performing Salome, Revealing Stories* (2013). She has also published in *Revue de musicologie*, *Music in Art*, *Franco-British Studies*, *Avant-Scène Opéra* and regularly contributes chapters concerning opera and dance to the *Cahiers de l'Esplanade*, and programme notes for the Royal Opera House, Covent Garden.

Alexandra Wilson, contributing co-editor of this issue, is Reader in Musicology at Oxford Brookes University, where she co-directs the OBERTO opera research unit. She is author of *The Puccini Problem: Opera, Nationalism, and Modernity* (Cambridge University Press, 2007, winner of the Lewis Lockwood Award from the American Musicological Society) and *Opera: A Beginner's Guide* (2010). Her work has appeared in *Music & Letters*, *Cambridge Opera Journal*, *The Opera Quarterly* and *Nineteenth-Century Music Review*, and she regularly writes programme essays for the Royal Opera House, Covent Garden.
