## CONTRIBUTORS

**George Sher** is Herbert S. Autry Professor of Philosophy and Chair of the Philosophy Department at Rice University, where he has taught since 1991. Previously he taught for seventeen years at the University of Vermont. He is the author of *Desert* (1987) and *Beyond Neutrality: Perfectionism and Politics* (1997), a coeditor of *Reason at Work: Introductory Readings in Philosophy* (3d ed., 1996), and the editor of *Moral Philosophy: Selected Readings* (2d ed., 1996). A collection of his papers, *Approximate Justice: Studies in Non-Ideal Theory*, was published in 1997.

**L. W. Sumner** is Professor of Philosophy and Law at the University of Toronto. He received his Ph.D. from Princeton University and is the author of *Abortion and Moral Theory* (1981), *The Moral Foundation of Rights* (1987), and *Welfare, Happiness, and Ethics* (1996), as well as numerous articles in ethics, political philosophy, and philosophy of law.

**Julia Annas** is Regents Professor of Philosophy at the University of Arizona. She has also taught at St. Hugh's College, Oxford, and at Columbia University. She has been a Getty Scholar and is Townsend Lecturer for 1997 at Cornell University. She is a member of the American Academy of Arts and Sciences, and a Senior Fellow of the Center for Hellenic Studies. She has written numerous books and articles on ancient philosophy, mainly on ethics and epistemology; her most recent major book is *The Morality of Happiness* (1993), on the structure of ancient ethical theory.

**James Griffin** is White's Professor of Moral Philosophy and Fellow of Corpus Christi College, Oxford University. He is the author of *Well-Being* (1986) and of *Value Judgement: Improving Our Ethical Beliefs* (1996). He is currently working on two subjects in particular: rights and the ethical view that he sketches in his contribution to this volume.

**Tara Smith** is Associate Professor of Philosophy at the University of Texas at Austin. She is the author of *Moral Rights and Political Freedom* (1995) and has written several articles on aspects of rights, virtues, and values appearing in such journals as the *Journal of Philosophy*, *Law and Philosophy*, and the *Southern Journal of Philosophy*. She is currently writing a book on the foundations of value.

**Robert C. Solomon** is Quincy Lee Centennial Professor of Business and Philosophy at the University of Texas at Austin. He is the recipient of several teaching awards and honors, including the 1973 Standard Oil Outstanding Teaching Award, the University of Texas Presidential Asso-

ciates' Teaching Award (twice), a Fulbright Lecture Award, and a National Endowment for the Humanities grant. He is the author of *The Passions* (1976), *In the Spirit of Hegel* (1983), *About Love* (1988), and *A Passion for Justice* (1990), and of four books on ethics, including *Ethics and Excellence* (1991). His most recent book, coauthored with Kathleen Higgins, is *A Short History of Philosophy* (1996).

**Nancy Sherman** is Professor of Philosophy at Georgetown University, where she has taught since 1989. She previously taught at Yale University, and has taught on visiting appointments at the University of Maryland and Johns Hopkins University. She is also the inaugural holder of the Distinguished Chair of Ethics at the United States Naval Academy, where she held a visiting position in 1997. She is the author of two books, *The Fabric of Character: Aristotle's Theory of Virtue* (1989) and *Making a Necessity of Virtue: Aristotle and Kant on Virtue* (1997). Her published essays have focused on Kantian and Aristotelian ethics, as well as issues in moral psychology. She is presently working on a larger project on the role of attachment emotions in the good life.

**Robert Audi** is Charles J. Mach Distinguished Professor of Philosophy at the University of Nebraska, Lincoln. He works in the fields of theoretical and applied ethics, epistemology (including moral and religious epistemology), and related areas of philosophy of mind and action, especially the theory of rational action. His books include *Practical Reasoning* (1989), *Action, Intention, and Reason* (1993), *The Structure of Justification* (1993), and *Moral Knowledge and Ethical Character* (1997).

**Michael Slote** is Professor of Philosophy and Chair of the Philosophy Department at the University of Maryland, College Park. He is the author of several books in ethics, including *Goods and Virtues* (1983) and *From Morality to Virtue* (1992). With Marcia Baron and Philip Pettit, he has recently coauthored a book, *Three Methods of Ethics: A Debate* (1997), in which the merits of utilitarianism, Kantian ethics, and virtue ethics are debated. He is currently working on applying agent-basing techniques to the theory of rational choice and to practical reason generally.

**Ronald D. Milo** is Professor of Philosophy at the University of Arizona. He is the author of *Immorality* (1984) and of several articles on moral philosophy, which have been published in such journals as *The Monist* and the *Journal of Philosophy*. At present he is working on a book focusing on questions about truth and objectivity concerning moral opinions.

**John Kekes** is Professor of Philosophy and Public Policy at the State University of New York at Albany. He is the author of many books and articles on political philosophy, ethics, and epistemology. His most recent

books are *Facing Evil* (1990), *The Morality of Pluralism* (1993), *Moral Wisdom and Good Lives* (1995), and *Against Liberalism* (1997).

**John M. Cooper** is Professor of Philosophy at Princeton University. He received his Ph.D. from Harvard University and has taught at Harvard, the University of Pittsburgh, and Stanford University. He is the author of *Reason and Human Good in Aristotle* (1975), and the coeditor of *Seneca: Moral and Political Essays* (1995). His edition of *Plato: Complete Works* in English translation was published by Hackett Publishing Company in 1997.

**Douglas J. Den Uyl** is Professor of Philosophy at Bellarmine College in Louisville, Kentucky. His interests are in the areas of social and political philosophy and ethics. Among his books are *Power, State, and Freedom: An Interpretation of Spinoza's Political Thought* (1983), *Liberty and Nature: An Aristotelian Defense of Liberal Order* (with Douglas B. Rasmussen, 1991), and *The Virtue of Prudence* (1991). His articles include studies of historical figures as well as treatments of topical issues in ethics and political theory.
