
NAS Exchanges with USSR and Eastern European Academies

The National Academy of Sciences invites applications from American scientists who wish to make visits beginning during the period September 1977 through August 1978 in the USSR, Bulgaria, Czechoslovakia, Hungary, Poland, Romania or Yugoslavia. Long-term research visits of five to twelve months' duration are encouraged, particularly those where contact with colleagues of the receiving academy has already been established.

Applicants must be U.S. citizens and have a doctoral degree or its equivalent in mathematics; the physical, biological, or engineering sciences; social or behavioral sciences; or medical sciences (non-patient oriented) by the time of the intended visit. For the purpose of the exchange programs, those areas in the social and behavioral sciences which are oriented toward empirical and quantitative analysis and which focus on the analysis of individual and group behavior are included. All necessary expenses will be met by the NAS and the foreign academy, including reimbursement for salary lost up to a predetermined maximum and expenses for accompanying family members on visits of five months or more.

Requests for applications should reach the National Academy of Sciences not later than November 5, 1976; deadline for receiving completed applications is November 19, 1976. Fellows in the Foreign Policy Studies Program will be William Bajusz, University of Wisconsin, whose dissertation topic is "Transnational Organizational Interaction and Common Problem Solving Across National Boundaries: U.S. Participation in Cooperative Weapons Acquisition in NATO"; and Thomas McNaugher, Harvard University, "Bureaucratic Politics and Arms Control: The Case of the M.16 Rifle."

A limited number of Brookings Research Fellowships are awarded annually to candidates who have completed their preliminary examinations and are nominated by their graduate departments. Nominations for 1977-78 must be received not later than December 15, 1976. Essential criteria for the award are relevance of the topic to the research programs of Brookings and evidence that the research will be facilitated by access to the Institution's resources or to the federal government. NSF Innovative Teaching Project Award

The Department of Political Science of Heidelberg College has been awarded a \$21,000 grant for a National Science Foundation Innovative Teaching Project.

These faculty-oriented projects are supported under the NSF's Restructuring the Undergraduate Learning Environment (RULE) program with two principal objectives: (1) enhancing the teaching vitality of science faculty, and (2) insuring the rapid dispersal of important new scientific and educational concepts throughout the Nation's colleges. These awards are relatively modest in size, ranging between \$2,800 and \$25,000, and generally support an individual or a small group of science faculty members, sometimes with student assistance, for intensive work during a specific time period, such as a summer term.

New York Council for the Humanities

The New York Council for the Humanities provides support for scholars in the humanities

for a critical examination of public policy issues. The Council recently awarded a \$7,000 grant to C. Anthony Broh, James L. Crout-hamel, Thomas M. Millington, and Ann Palmeri to conduct a community symposium titled "A Bicentennial Perspective on the Bill of Rights." The symposium was held April 19-25, 1976, on the campus of Hobart and William Smith Colleges in Geneva, New York, and involved 26 speakers and four films.

NATO Postdoctoral Fellowship

Michael Lewis-Beck of the University of Iowa has been selected as one of 47 National Science Foundation-Department of State North Atlantic Treaty Organization Postdoctoral Fellowships in Science. He will attend the Institution d'Etudes Politiques in Paris on his Fellowship.
