This aspect of the Quebec provisions is not something that appears to have interested Crépeau, but then this is not a work that gives the impression that it has been written with the common lawyer in mind. This is regrettable, if only because it seems to confirm the thesis that there is only one view of contract (cf. Legrand (1998) 18 L.S. 216). For better or for worse, there might well be some jurists who believe that the UNIDROIT principles do not give a definitive view of contract law. What they give is one, if elegant and humane, view.
