# Global Perspectives Begins Publication

*Global Perspectives* will begin publication in the fall 1982, the first interdisciplinary journal of international relations devoted exclusively to the advanced research of senior undergraduate and graduate students. The journal's purpose is to provide a forum for responsible, objective expression at the college level, and the opportunity for qualified students to publish and progress in the field.

We are currently accepting manuscripts for the first issue. Guidelines: (1) send three copies of the paper to be considered (papers not returned); (2) we prefer that manuscripts be accompanied by a note of approval from the professor who supervised the paper: (3) the manuscript must be typed, double-spaced, and photocopied (no originals); (4) attach a title page with name, college, class level, major, title of the paper, word count, and an abstract of 125 words; (5) use the generally accepted style for scholarly articles, with parenthetical references included in the text, sources listed at the end; (6) length should be up to 3,500 words, although an outstanding longer piece of research may be considered. Of particular interest are papers presented at local, regional and national conferences, seminar papers, and independent studies, although any quality research will be accepted for review.

The editor-in-chief of Global Perspectives is John C. Bersia, and the managing editor is John C. Di Pierro, of the University of Central Florida. The editorial staff will provide expertise in all important areas of international relations-politics, organization, theory, methodology, and all related subjects. Members of the editorial boards thus far are: Susan Strange (London School of Economics), Michael Frv (University of Southern California), Stephen Blank (Multinational Strategies, Inc.), Jack Plano (Western Michigan University), Inis Claude (University of Virginia), Kenneth Rabin (E.R. In addition, a new association, the Transnational Studies Association, has been formed. Membership in the association, subscription to the journal (initially published semi-annually), and other mailings about the activities of the association are included in the membership fee of \$9 for students, \$15 for professionals, \$20 for institutions, and \$25 for sustaining members. The regular features of *Global Perspectives* will include articles, book reviews, a guest editorial, an editor's forum, and a letters to the editor section. # Law School Home For New Law Journal

The Journal of Law and Politics was recently established at the University of Virginia School of Law to analyze the role of law in the political process and the role of politics in the legal process. Although there are many political science and legal journals, there is no journal devoted to analyzing the relationship between law and politics. The Journal would be the first academic journal of its kind in the country, publishing articles of independent legal scholarship on such topics as campaign finance, voting rights and ballot access, congressional oversight, lobbying, and party rules.

The *Journal* will be an interdisciplinary publication, edited by students from the law school and government department and supervised by law and government professors. With its Jeffersonian heritage, its vast resources, its proximity to the nation's capital, and its politically active and interested student body and faculty, the University of Virginia School of Law is the ideal home for this needed publication.

With the first issue scheduled for publication in the spring/summer of 1983, the *Journal* will publish two 200-page issues each year. The material in each issue, which will be directed to scholars, practitioners, and policy-makers, will consist of articles by experts and case comments on important court decisions by students.

The Managing Board has chosen the theme "The Election of the President" for the first issue. Possible topics for manuscripts include:

- Presidential primary and nomination law
- Political advertising and media access
- Election process and post election challenges
- Campaign finance law
- Third-party and independent candidate ballot access law
