Statement of Purpose



Although concentrated on specific topics, articles illuminate larger patterns, implications, or contexts of American life. *Religion and American Culture* is, thus, devoted to promoting the ongoing scholarly discussion of the nature, terms, and dynamics of religion in America.

Religion and American Culture (ISSN 1052-1151) is published bi-annually by Indiana University Press for the Center for the Study of Religion and American Culture at Indiana University-Purdue University, Indianapolis, which assumes no responsibility for opinions expressed by contributors. Subscriptions are available to institutions at \$25.00 per volume and to individuals at \$15.00 per volume. Surface postage for subscriptions outside the USA is \$7.00 per volume. Single issues are available to institutions at \$20.00 each and to individuals at \$10.00 each, plus \$1.25 per issue for postage.
