
Notes on Contributors

Francisco Cobo Romero is Professor of Contemporary Spanish History at the University of Granada. He has published on radicalisation and repression in rural Spain during the Second Republic, the civil war and the post-war. His works include: *De campesinos a electores. Modernización agraria en Andalucía, politización campesina y derechización de los pequeños propietarios y arrendatarios. El caso de la provincia de Jaén, 1931–1936* (2003) and, more recently, *Por la reforma agraria hacia la revolución: el sindicalismo agrario socialista durante la II República y la Guerra Civil, 1930–1939* (2007). Miguel Ángel del Arco Blanco is Profesor Ayudante Doctor in the Department of Contemporary History at the University of Granada. His work centres on the study of the Spanish Civil War and post-war Francoism, particularly the issue of consent and the social and economic consequences of Franco's post-war policy of autarky. He recently published '*Hambre de siglos*'. *Mundo rural y apoyos sociales del franquismo en Andalucía Oriental (1936–51)* (2007). Teresa María Ortega López is Profesora Titular of Contemporary History at the University of Granada. She works on both early and late Francoism, focusing on repression, poverty, labour relations and gender history. Her publications include *Del silencio a la protesta: explotación, pobreza y conflictividad en una provincia andaluza, Granada* (2003) and, with Cobo Romero, *Franquismo y posguerra en Andalucía Oriental: represión, castigo a los vencidos y apoyos sociales al régimen franquista (1936–1950)* (2007). At present, the authors are conducting research on the 'culture of victory' forged by the Francoist regime after the civil war.

John R. Lampe is Professor of History at the University of Maryland, College Park and a Senior Scholar at the Woodrow Wilson International Center for Scholars in Washington, DC, where he previously served as Director of East European Studies. From an initial background in the diplomatic service and then doctoral training in European economic history, he has devoted the subsequent decades to studying modern Balkan history in general and the former Yugoslavia in particular. His most recent monographs are *Yugoslavia as History: Twice there was a Country*, 2nd ed. (2000) and *Balkans into Southeastern Europe, A Century of War and Transition* (2006).

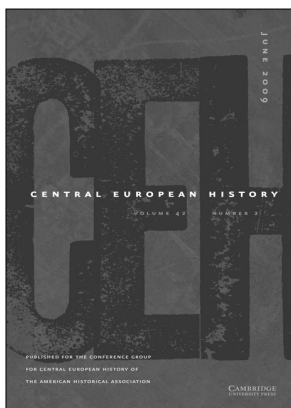
Michael Seidman is Professor of History at University of North Carolina Wilmington. His research focuses on social and individual history of Spain and France in the

twentieth century. His most recent book is *The Victorious Counterrevolution: The Nationalist Effort in the Spanish Civil War* (University of Wisconsin Press, 2011, forthcoming). His first book, *Workers against Work: Labor in Paris and Barcelona during the Popular Fronts (1936–38)*, has been translated into four languages.

Matthew Stibbe is Professor of Modern European History at Sheffield Hallam University. He is interested, among other things, in GDR historians and the environment in which they worked, and is currently participating in a collaborative project on historiography in East and West Germany during the cold war based at the University of Jena. His most recent publications include *Germany 1914–1933: Politics, Society and Culture* (2010); and (co-edited with Kevin McDermott) *Stalinist Terror in Eastern Europe: Elite Purges and Mass Repression* (2010).

Frank Trentmann is Professor of History at Birkbeck College, University of London. From 2002 until 2007, he directed the £5 million Cultures of Consumption research programme. His work has focused on the history of consumption, civil society and politics. He is the author of *Free Trade Nation: Commerce, Consumption and Civil Society in Modern Britain* (2008), which won the Whitfield Prize, and editor of several collections, including *Consuming Cultures, Global Perspectives* (with John Brewer, 2006) and *Citizenship and Consumption* (with Kate Soper, 2007). He is particularly interested in putting current debates about consumption in their longer historical context – the theme of his current book project for Penguin: *The Consuming Passion: How Things Came to Seduce, Enrich, and Define our Lives, Eighteenth Century to the Twenty-First* (forthcoming).

Andreas Wirsching is Professor of Modern and Contemporary History at the University of Augsburg. His fields of special interest are French and German history in the inter-war period, the history of the Nazi period and European history since the 1970s. His recent publications include: *Abschied vom Provisorium. Geschichte der Bundesrepublik Deutschland 1982–1990* (2006); *Das Jahr 1933. Die nationalsozialistische Machteroberung und die deutsche Gesellschaft* (ed., 2009); 'Violence as Discourse? For a 'Linguistic Turn' in Communist History', in *Twentieth Century Communism: A Journal of International History*, 2, 1 (2010), 12–39.

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at ceh@sheffield.ac.uk, or, in the case of submissions from North America, to the Corresponding Editor for North America, Professor Amir Weiner, weiner@stanford.edu

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers should send a final version via email. This should include

1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short description of work in progress and previously published work
