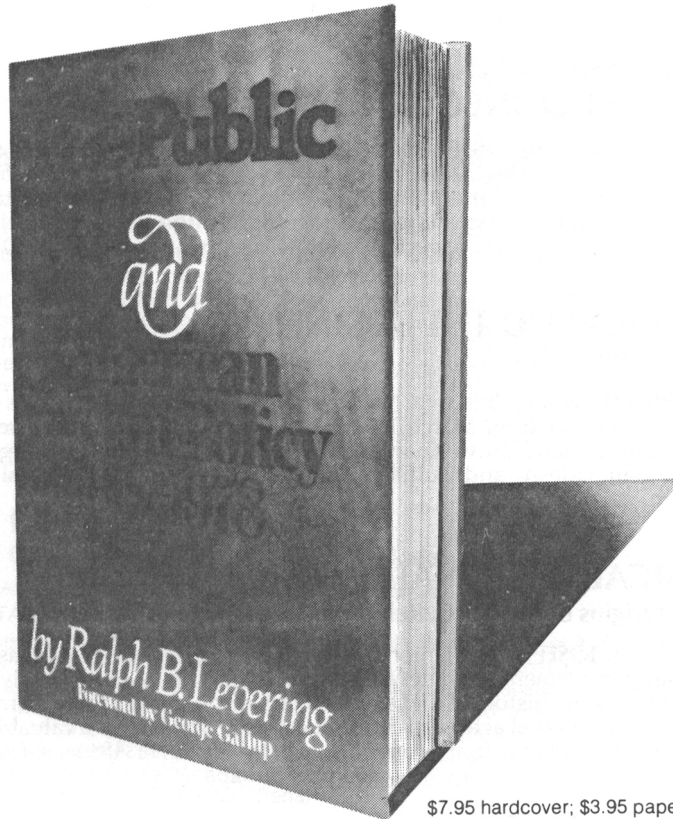

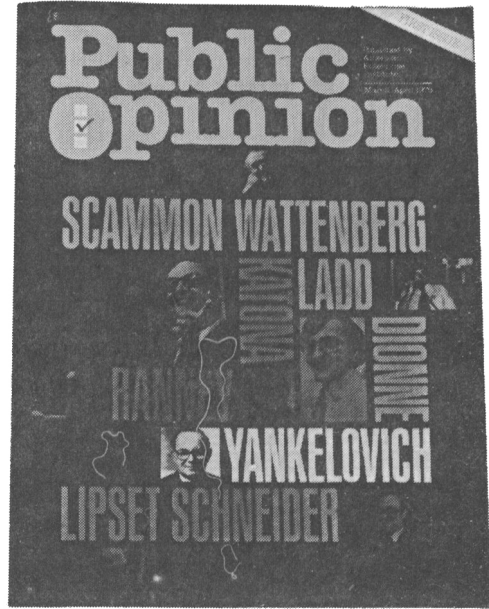

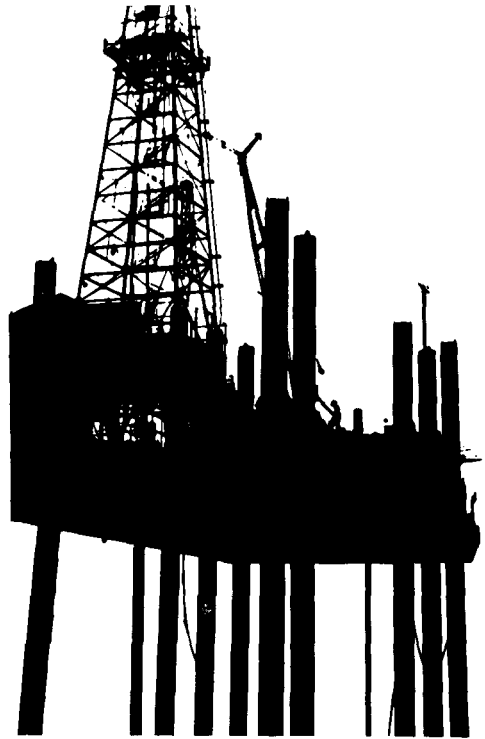

This information system is now in published form and known as *United States Political Science Documents*.

The *Political Science Thesaurus* comprises, in addition to a forward and a preface, a *Description and Use of the Thesaurus* section, the *Thesaurus of Terms*, a *Permuted Index*, a *Hierarchical Index*, and three *Appendices—Thesaurus Rules and Conventions*, *Sources of Terms Used in the Data Bank*, and a list of *Participants* in the production and creation of the *Thesaurus*. The main body of the publication—the *Thesaurus of Terms*—consists of *Part I: Political Science Terminology* and *Part II: Geographical/Political Areas*.

The *Political Science Thesaurus* is available in both casebound and paperback editions of 470 pages.
