In an era when many people are either predicting or recommending an end to bureaucratic forms of organization in government, this book attempts to determine when, how, and why the Federal government became a bureaucracy in the first place. Some of the most critical steps in the process, according to the author, appear to have been taken during the administration of Andrew Jackson.

Jackson is rarely thought of as a founder of bureaucracy, but during the second half of his administration nearly every Federal agency was overhauled at least once. Matthew Crenson traces the process in detail in the two then-largest agencies of the U.S. government—the Post Office Department and the General Land Office—and attempts to identify the conditions that triggered reorganization.

# HUTTERITE SOCIETY

*John A. Hostetler*

The conditions of life in urban America today have led many young people to seek something rarely achieved: a successful and continuing communal way of life. In *Hutterite Society* John Hostetler gives a complete and fascinating picture of the largest and oldest family-type communal society in North America, the Hutterite Brethren, this year marking their 100th anniversary on that continent.

Now numbering over 21,000, the Hutterites live in the Great Plains areas of the United States and Canada in colonies of 70 to 140. Since private ownership of property is forbidden to this German Anabaptist sect, members work without the incentive of private gain. Although they eschew worldly ambitions, they use modern methods in the operation of their very effective agricultural enterprises.

*Hutterite Society* traces back four hundred years to the founding of the sect and its travels throughout Europe and eventually to America. The greater part of the book deals with Hutterite communal life today—colony organization, economic survival, attitudes, and lifestyle.

## **Curing the Mischiefs of Faction**

### **Party Reform in America**

*Austin Ranney*

James Madison's warning that the first objective of any republican government must be the search for "methods of curing the mischiefs of faction" provides the launching point for Austin Ranney's review of the theory and practice of party reform in America.

Focusing on the three main periods of reform, 1820-1840, 1890-1920, and 1956 to the present, Mr. Ranney argues that party rules and procedures have never been politically neutral and he describes which candidates and factions won and lost from each of the major reforms. He shows that Americans in all periods of our history, including the present, have had ambivalent feelings about the institution of parties, some wishing to abolish them, others wishing to leave them alone, but most wishing neither. The author's main thesis is that reform has always offered such people, and continues to offer them, a convenient escape from the difficult choice of abolishing parties or smoothing their way.

### NOTES FOR CONTRIBUTORS

1. All contributions and editorial correspondence should be sent to: The Editor, *Journal of American Studies*, Department of American Studies, The University, Manchester M13 9PL, England.
2. Articles should generally contain about 5000 words. Longer or shorter articles, or articles in two or more parts, may be accepted by arrangement with the Editor.
3. Submission of an article is taken to imply that it has not previously been published, or is not being considered for publication elsewhere.
4. Contributions should be clearly typed in double spacing, preferably on A4 paper, with a wide left-hand margin. Diagrams and maps may be included by arrangement with the Editor.
5. Footnotes should be used sparingly: in general, to give sources of direct quotations, references to main authorities on disputable questions, and evidence relied on for a new or unusual conclusion. They should be numbered in one sequence throughout the article, and should preferably be typed in double spacing at the end of the article.
6. Contributors should keep one copy of the typescript for correcting proofs.
7. Notes intended for the Editor or printer should be on a separate sheet.
8. First proofs may be read and corrected by contributors provided that they can give the Editor an address through which they can be reached without delay and can guarantee to return the corrected proofs to the Editor, by airmail where necessary, within ten days of receiving them.
9. Correction should be kept to an absolute minimum. It should be confined to errors of the typist or printer unless the Editor authorizes otherwise.
10. Contributors of articles and review articles receive 25 free separates. Extra copies may be ordered according to the scale of charges.
11. Contributors need not be members of the British Association for American Studies. Unsolicited typescripts can only be returned to overseas contributors who send International Reply Coupons (not postage stamps).
12. Contributors of accepted articles will be asked to assign their copyrights, on certain conditions, to Cambridge University Press, to help protect their material, particularly in the U.S.A.
