

THE CARDINALITY OF THE SET OF LEFT INVARIANT MEANS ON TOPOLOGICAL SEMIGROUPS

For a very large class of topological semigroups, we establish lower and upper bounds for the cardinality of the set of left invariant means on the space of left uniformly continuous functions. In certain cases we show that such a cardinality is exactly 2^{2^b} , where b is the smallest cardinality of the covering of the underlying topological semigroup by compact sets.

1 INTRODUCTION

Let G be a non-compact locally compact topological group such that $L^\infty(G)$ admits a topologically left invariant mean, and let $TLIM(G)$ be the set of all such means. Various studies have looked at the size of such a set. In particular when G is σ -compact, Chou [1] showed that $\text{card}(TLIM(G)) \geq 2^c$, and when G is discrete, he [2] showed that $\text{card}(TLIM(G)) = 2^{2^{|G|}}$. (Here c is the cardinality of the continuum and $|G|$ is the cardinality of G .) Generalising the latter result, Lau and Paterson [10] proved that $\text{card}(TLIM(G)) = 2^{2^{b(G)}}$, where $b(G)$ is the smallest cardinality of a covering of G by compact sets. (The idea of employing $b(G)$ has been used earlier by Liu and van Rooij [11].) Also for certain discrete semigroups, S , Klawe [9] showed that one may have the cardinality of the set of left invariant means on the bounded functions equal to $2^{2^{|S|}}$.

Now let S be a topological semigroup, $LUC(S)$ the space of left uniformly continuous functions on S and $M(S)$ the space of bounded Radon measures on S . Let $b(S)$ (or $d(S)$) be the cardinality of a covering of S by compact (or respectively, relatively neo-compact) sets. (For definitions see section 2.) In this paper, for a large class of S , for which groups G (as mentioned above) are a very special case, we show that the cardinality of the set of left invariant means on $LUC(S)$, and that of topologically left invariant means on $M(S)^*$, lies between $2^{2^{b(S)}}$ and $2^{2^{d(S)}}$. For many cases we also have $b(S) = d(S)$.

In section 2, we collect together some definitions and preliminary results, and then formally state our results in section 3. Some results employed at critical points of our proofs are collected into lemmas in section 4. Sections 5 to 7 contain proofs of the results stated in section 3. We give a more detailed proof in section 5 upon which later proofs are moulded. We conclude the paper with a few remarks in section 8.

For other results on sizes of sets of invariant means, the interested reader is referred to [1], [2], [5], [9], [10], [12] and to the references mentioned therein.

2 PRELIMINARIES

2.1 Terminology. By *topological semigroup*, we mean a semigroup S endowed with a Hausdorff topology with respect to which the semigroup operation $(x, y) \rightarrow xy$ defines a jointly continuous mapping of $S \times S$ into S .

Let S be a topological semigroup throughout this section.

For any subsets A, B and $\{x\}$ of S , we employ the following notation:

$$\begin{aligned} A^{-1}B &:= \{y \in S : ay \in B \text{ for some } a \in A\} \\ x^{-1}B &:= \{x\}^{-1}B \\ A^{-1}x &:= A^{-1}\{x\} \end{aligned}$$

By symmetry, one similarly defines right handed versions BA^{-1} , Bx^{-1} and xA^{-1} .

In particular, if A_1, A_2, \dots, A_n are subsets of S , we write

$$\begin{aligned} A_1 \oplus A_2 &:= \{A_1A_2, A_1^{-1}A_2, A_1A_2^{-1}\} \\ A_1 \oplus A_2 \oplus A_3 &:= [\cup\{A_1 \oplus B : B \in A_2 \oplus A_3\}] \cup [\cup\{B \oplus A_3 : B \in A_1 \oplus A_2\}] \end{aligned}$$

and hence inductively define $A_1 \oplus A_2 \oplus \dots \oplus A_n$.

Following [5] and [6], a subset B of S is said to be *relatively neo-compact* if B is contained in a (finite) union of sets in $A_1 \oplus A_2 \oplus \dots \oplus A_n$, for some compact sets A_1, A_2, \dots, A_n of S . In particular if $C^{-1}D$ and DC^{-1} are compact sets, for all compact subsets C and D of S , then relatively neo-compact subsets are precisely the relatively compact subsets. For brevity, we write \overline{B} for the closure of a set B and $|B|$ for its cardinality.

Recall that $b(S)$ (respectively, $d(S)$) is the smallest possible cardinality of a covering of S by compact (respectively, relatively neo-compact) subsets of S . We thus have $d(S) \leq b(S)$ always. Also the following result is evident; we quote it for easy reference.

2.2 PROPOSITION. *Let S be non-relatively neo-compact. Then*

- (a) *if S is σ -compact, we have that $b(S) = d(S) = \aleph_0$.*
- (b) *if the sets CD^{-1} and DC^{-1} are compact for all compact subsets C and D of S , then $b(S) = d(S)$.*

2.3 Notation. Let $C(S)$ denote the space of all *bounded continuous complex-valued functions* on S , and $M(S)$ the set of all *bounded complex-valued regular Borel measures* on S .

For every function f in $C(S)$ and point x in S , we have the functions ${}_x f$ and f_x in $C(S)$ given by

$${}_x f(y) := f(xy) \text{ and } f_x(y) := f(yx) \quad (y \in S).$$

The space of *left uniformly continuous functions* on S is

$$LUC(S) := \{f \in C(S) : \text{the map } x \rightarrow {}_x f \text{ of } S \text{ into } C(S) \text{ is norm-continuous}\}$$

Following [4] we say that S is *C-distinguished* if the real-valued functions in $C(S)$ separate points.

For a C -distinguished S we have $M(S)$ a Banach algebra under the usual total variation norm $\|\cdot\|$ and with convolution multiplication given by

$$\nu^* \mu(A) := \iint \chi_A(xy) d\nu(x) d\mu(y)$$

for all $\nu, \mu \in M(S)$ and Borel subsets A of S ; where χ_A denotes the characteristic function of the set A . For h in $M(S)^*$ and ν, μ in $M(S)$, we may then define νoh , $ho\mu$ and $\nu oho\mu$ in $M(S)$ by

$$\begin{aligned} \nu oh(\eta) &:= h(\nu^* \eta), & ho\mu(\eta) &:= h(\eta^* \mu) \\ \text{and } \nu oho\mu(\eta) &:= h(\nu^* \eta^* \mu) \text{ for all } \eta \in M(S). \end{aligned}$$

In particular for $x \in S$ and $f \in C(S)$ we have that

$$\delta_x of = {}_x f,$$

where δ_x denotes the point mass of x and f is identified with the functional in $M(S)^*$ given by $\nu \rightarrow \int f(y) d\nu(y)$, for all $\nu \in M(S)$.

We define $\text{supp}(\mu) := \{x \in S : |\mu|(V) > 0 \text{ for every open neighbourhood } V \text{ of } x\}$, for all μ in $M(S)$. In particular, for every subset M_0 of $M(S)$, by the *foundation of M_0* , we mean the closure of the set $\cup\{\text{supp}(\mu) : \mu \in M_0\}$.

For any S , we define the set of *absolutely continuous measures*, $M_a(S)$, by

$$\begin{aligned} M_a(S) &:= \{\mu \in M(S) : \text{the maps } x \rightarrow |\mu|(x^{-1}K) \text{ and } x \rightarrow |\mu|(Kx^{-1}) \text{ of } S \\ &\text{into } R \text{ are continuous, for all compact } K \subset S\}. \end{aligned}$$

(Here $|\mu|$ denotes the measure arising from the total variation of μ .)

For semigroups S , $M_a(S)$ plays a role analogous to that played by the group algebra $L^1(G)$ for locally compact groups G . A comprehensive study of $M_a(S)$ can be found in [5].

The following definition is of particular importance in our paper:

2.4 Definition. Let S be a topological semigroup with an identity element 1 and such that, for every neighbourhood U of 1 , we have

- (a) $x \in \text{int}[U^{-1}(Ux) \cap (xU)U^{-1}]$ for all x in S ,
- (b) $1 \in \text{int}(U^{-1}v \cap wU^{-1})$ for some w and v in U .

Following [13], if S is also locally compact, we say S is a *stip*.

The class of semigroups called stips is very large—see for example [5] and [15]. Their importance partly arises from the fact that every topological semigroup, S , with an identity element and such that S coincides with the foundation of $M_\alpha(S)$, satisfies items (a) and (b) of Definition 2.4—see for example [5, Chapter 3, Theorem 1.2].

2.5 Some aspects of stips. For ease of reference we briefly list some results on stips. Full details on these can be found in [13] and [5]. Let S be a stip with an identity element 1 , throughout this section.

- (i) If W is a compact neighbourhood of 1 , we can find a sequence of open neighbourhoods of 1 , $\{W_k\}$, and a pseudometric, ρ , such that

$$W_{k+1}^{-1}(W_{k+1}x) \subseteq \{y \in S : \rho(y, x) \leq 2^{-k+1}\} \subseteq W_k^{-1}(W_kx),$$

$$\text{and } \rho(xz, yz) \leq \rho(x, y)$$

for all $x, y, z \in S$ and $k \in \mathbb{N}$.

- (ii) One can employ a standard argument to show that, for a function f in $C(S)$ we have that $f \in LUC(S)$ if and only if, given $\varepsilon > 0$ we can find a neighbourhood 0 of 1 such that $0x \cap 0y \neq \emptyset$ implies $|f(x) - f(y)| < \varepsilon$ ($x, y \in S$).
- (iii) Let E be the set of all *idempotent* elements of S . For every e in E , we have that eSe is a stip with identity element e . We say e is a δ -*isolated idempotent* if $\{e\}$ is a G_δ -set in $eSe \cap E$.

2.6 Definitions. Let S be a C -distinguished topological semigroup.

$$P(S) := \{\mu \in M(S) : \|\mu\| = \mu(S) = 1\}$$

$$P_c(S) := \{\nu \in P(S) : \text{supp}(\nu) \text{ is compact}\}$$

and let A be a subspace of $M(S)^*$ such that $\mu oh \in A$ for all μ in $M(S)$ and h in A .

We say $m \in A^*$ is a *mean* on A if

$$\|m\| = m(e) = 1 \text{ and } m(f) \geq 0 \text{ for every non-negative } f \text{ in } A.$$

A *left invariant mean (LIM)* on A is a mean on A such that

$$m(\delta_x oh) = m(h) \text{ for all } x \in S \text{ and } h \in A.$$

A *topologically left invariant mean (TLIM)* on A is a mean m on A such that

$$m(\mu oh) = m(h) \quad (\mu \in P(S) \text{ and } h \in A).$$

We denote the set of all LIMs (respectively, TLIMs on A by $LIM(A)$ (respectively $TLIM(A)$).

3 STATEMENT OF RESULTS

3.1 THEOREM. *Let S be a non-relatively neo-compact stip with $LUC(S)$ admitting a left invariant mean. Then*

$$\text{card}(LIM(LUC(S))) \geq 2^{2^{d(S)}}.$$

For certain stips we improve the preceding result as follows:

3.2 THEOREM. *Let S be a non-relatively neo-compact stip with $LUC(S)$ admitting a left invariant mean. Then*

- (i) $2^{2^{b(S)}} \geq \text{card}(LIM(LUC(S))) \geq 2^{2^{d(S)}}$ if S is either commutative or has a δ -isolated identity;
- (ii) $\text{card}(LIM(LUC(S))) = 2^{2^{b(S)}}$ if S is either σ -compact or as in (i) but with $C^{-1}D$ and DC^{-1} compact, for all compact subsets C and D of S .

For semigroups admitting absolutely continuous measures, we have the following Theorem for more general topological semigroups—including cases where the semigroup may not be locally compact.

3.3 THEOREM. *Let S be a non-relatively neo-compact C -distinguished topological semigroup such that $M_a(S)$ is non-zero. Then*

- (i) if $LUC(S)$ admits a left invariant mean we have that

$$2^{2^{b(S)}} \geq \text{card}(LIM(LUC(S))) \geq 2^{2^{d(S)}};$$

- (ii) if $M(S)^*$ admits a left topologically invariant mean, we have that

$$2^{2^{b(S)}} \geq \text{card}(TLIM(M(S)^*)) \geq 2^{2^{d(S)}}.$$

In particular the inequalities in both (i) and (ii) reduce to equalities if, in addition, either

- (a) S is σ -compact;
- or (b) S is such that $C^{-1}D$ and DC^{-1} are compact, whenever C and D are compact subsets of S .

3.4 COROLLARY. *Let S be a non-compact topological semigroup with an identity element such that S coincides with the foundation of $M_a(S)$, the sets $C^{-1}D$ and DC^{-1} are compact whenever C and D are compact subsets of S . If $LUC(S)$ admits a left invariant mean, then*

$$\text{card}(TLIM(M(S^*))) = \text{card}(TLIM(M_a(S)^*)) = \text{card}(LIM(LUC(S))) = 2^{2^{d(S)}}.$$

In particular we have the following corollary which also contains the result of Lau and Paterson [10].

3.5 COROLLARY. *Let G be a non-compact locally compact group such that $LUC(G)$ admits a left invariant mean. Then*

$$\text{card}(TLIM(M(G)^*)) = \text{card}(TLIM(L^\infty(G))) = \text{card}(LIM(LUC(G))) = 2^{2^{d(G)}}.$$

The next result is of particular interest for situations where the underlying topological semigroup S does not support absolutely continuous measures and does not have the “nice” topological structure of a stip.

3.6 THEOREM. *Let S be a C -distinguished topological semigroup that is σ -compact and not relatively neo-compact. Then, if $M(S)^*$ admits a topologically left invariant mean, we have that*

$$\text{card}(TLIM(M(S)^*)) \geq 2^c,$$

where c denotes the cardinality of the continuum.

4 SOME KEY LEMMAS

A proof of the following lemma can be found in [3] for the case of a locally compact semigroup. However, one can easily note that the proof also holds for our case.

4.1 LEMMA. *Let T be a Borel subset of a C -distinguished topological semigroup, S , and suppose that $M(S)^*$ admits a $TLIM$. Then the following items are equivalent:*

- (i) *there exists a $TLIM$, m , on $M(S)^*$ such that $m(\chi_T) = 1$;*
- (ii) *for each ν in $P(S)$ and $\varepsilon > 0$, we can find a point x in S such that $\nu^* \delta_x(T) > 1 - \varepsilon$.*

A mild adjustment (which we omit) of the argument given in [3] yields the following analogue of Lemma 4.1 for LIM on $LUC(S)$.

4.2 LEMMA. Let T be a subset of a C -distinguished topological semigroup S and suppose that $LUC(S)$ admits a LIM. Then the following are equivalent:

- (i) there exists a TLIM, m , on $LUC(S)$ such that $m(f) = 1$, for every $f \in LUC(S)$ with $0 \leq f \leq 1$ and $f = 1$ on T ;
- (ii) for each ν in $P_c(S)$ and $\epsilon > 0$, we can find x in S such that $\nu^* \delta_x(f) > 1 - \epsilon$, for every $f \in LUC(S)$ with $0 \leq f \leq 1$ and $f = 1$ on T .

Our next two lemmas together generalise [10, Lemma 1 and Proposition 1].

4.3 LEMMA. Let S be a non-relatively neo-compact C -distinguished topological semigroup and V be a compact subset. Let α be the smallest ordinal having cardinality $d(S)$ and $\{C_\beta : 1 \leq \beta < \alpha\}$ be a family of relatively neo-compact neighbourhoods covering S and closed under finite unions. Then

- (i) there exists a subset $\{x_{\beta\gamma} : 1 \leq \beta \leq \gamma < \alpha\}$ of S such that the sets $\{V^{-1}(VC_\gamma x_{\beta\gamma}) : 1 \leq \beta \leq \gamma < \alpha\}$ are pairwise disjoint;
- (ii) if $T_\beta := \cup\{C_\gamma x_{\beta\gamma} : \beta \leq \gamma < \alpha\}$, we have that \overline{T}_β satisfies item (ii) of both Lemma 4.1 and 4.2.

PROOF: (i) (see [10]). We employ a transfinite inductive argument based on the well-ordered set $\{(\gamma, \beta) : 1 \leq \beta \leq \gamma < \alpha\}$ where

$$(\gamma_1, \beta_1) < (\gamma_2, \beta_2) \text{ means } \gamma_1 < \gamma_2 \text{ or } \gamma_1 = \gamma_2 \text{ and } \beta_1 < \beta_2.$$

Let x_{11} be an arbitrarily chosen element of S . By the inductive hypothesis, suppose that $x_{\beta\gamma}$ has been chosen for all pairs $(\gamma, \beta) < (\gamma_0, \beta_0)$ with $1 \leq \beta \leq \gamma$. Setting $H := \cup\{VC_\gamma x_{\beta\gamma} : (\gamma, \beta) < (\gamma_0, \beta_0)\}$ we have that $H := (VC_{\gamma_0})^{-1}(VH)$ admits a covering, by relatively neo-compact sets, of cardinality less than $d(S)$. So we can choose $x_{\beta_0\gamma_0}$ in $S \setminus H$, which gives our inductive step and the result follows

(ii) Let ν be any measure in $P_c(S)$ and choose γ with $\beta \leq \gamma < \alpha$ such that $\text{supp}(\nu) \subset C_\gamma$. Then for $x = x_{\beta\gamma}$ we have

$$\text{supp}(\nu^* \delta_x) \subset \text{closure}(C_\gamma x) \subset \overline{T}_\beta \text{ and so } \nu^* \delta_x(\overline{T}_\beta) = 1.$$

This completes our proof. ■

4.4 LEMMA. Assume the notation of Lemma 4.3 and let $\Gamma := \{\beta : \beta \text{ is an ordinal with } 1 \leq \beta < \alpha\}$. Then if S is either

- (a) a stip
- or (b) such that $M_\alpha(S)$ is non-zero,

the subset V can be chosen so that for every $\Gamma_1 \subseteq \Gamma$, defining $T_{(\Gamma_1)} := \cup\{T_\beta : \beta \in \Gamma_1\}$ we get:

- (i) $\bar{T}_{(\Gamma_1)} = \cup\{\bar{T}_\beta : \beta \in \Gamma_1\}$;
- (ii) there exists a function f_{Γ_1} in $LUC(S)$ such that $0 \leq f_{\Gamma_1} \leq 1$, $f_{\Gamma_1} = 1$ on $\bar{T}_{(\Gamma_1)}$ and for $\Gamma_2 \subseteq \Gamma$ with $\Gamma_1 \cap \Gamma_2 = \emptyset$, we have $f_{\Gamma_1} \bullet f_{\Gamma_2} = 0$.

PROOF: Let $\Gamma_1 \subseteq \Gamma$ be fixed.

(a) We now prove (i) and (ii) for the case where S is a stip. First, by [5, Chapter 3, Theorem 2.6] or [13], we can choose sets V and W as follows:

$$(*) \quad \left\{ \begin{array}{l} \text{Let } Z \text{ and } W \text{ be compact neighbourhoods of the identity} \\ \text{of } S \text{ and } z \in Z \text{ such that} \\ W \subseteq Z^{-1}z \cap Z. \\ \text{We fix } V := Z^2 \text{ and } W \text{ to be the set stated in 2.5(i).} \end{array} \right.$$

To prove (i), let x be an element of $\bar{T}_{(\Gamma_1)}$. By definition of a stip, $V^{-1}(Vx)$ is a neighbourhood of x and so, there exists $\eta \in \Gamma_1$ with $V^{-1}(Vx) \cap T_\eta \neq \emptyset$. So for some γ with $\eta \leq \gamma < \alpha$, we have $V^{-1}(Vx) \cap C_\gamma x_{\eta\gamma} \neq \emptyset$. Consequently

$$(1) \quad x \in V^{-1}(VC_\gamma x_{\eta\gamma}).$$

From (1) and Lemma 4.3(i), we must have

$$V^{-1}(Vx) \cap C_\tau x_{\beta\tau} = \emptyset \text{ for } \beta \neq \eta$$

and so

$$V^{-1}(Vx) \cap T_\beta = \emptyset \text{ for } \beta \neq \eta.$$

Thus, if $0(x)$ denotes the interior of $V^{-1}(Vx)$, then

$$\bar{T}_{(\Gamma \setminus \{\eta\})} \subset S \setminus 0(x)$$

and so we must have

$$x \in \bar{T}_\eta.$$

Hence $\bar{T}_{(\Gamma_1)} \subset \cup\{\bar{T}_\beta : \beta \in \Gamma_1\}$. The reverse inclusion follows trivially. This proves (i).

Next we prove (ii). Consider the function f_{Γ_1} defined by

$$f_{\Gamma_1}(x) := 1 - \min(\rho(x, \bar{T}_{(\Gamma_1)}), 1) \quad (x \in S)$$

where ρ is the pseudometric introduced in item 2.5(i). Trivially, we have that f_{Γ_1} is continuous, $0 \leq f_{\Gamma_1} \leq 1$ and $f_{\Gamma_1} = 1$ on $\bar{T}_{(\Gamma_1)}$.

To show that f_{Γ_1} is $LUC(S)$, let $\epsilon > 0$ be given. By 2.5(i) and [13] (or [5, Chapter 3]) we can choose open neighbourhoods of the identity, 0 and U , such that

$$(2) \quad \begin{cases} 0 \subseteq U \subseteq W, \\ 0^{-1}(0x) \subseteq u^{-1}(Ux) \text{ for some } u \in U, \\ \text{and } 0y \cap 0x \neq \emptyset \text{ implies } \rho(x, y) < \epsilon(x, y \in S) \end{cases}$$

Now suppose $0y \cap 0x \neq \emptyset$, and consider the case where $f_{\Gamma_1}(x) \neq 0$. Then $\rho(x, \bar{T}_{(\Gamma_1)}) < 1$ and so $\rho(x, T_\beta) < 1$ for some $\beta \in \Gamma_1$. So we can find a γ with $\beta \leq \gamma < \alpha$ and $\rho(x, C_\gamma x_{\beta\gamma}) < 1$. By 2.5(i) and (*), we get

$$(3) \quad x \in W^{-1}(WC_\gamma x_{\beta\gamma}) \subset z^{-1}(ZWC_\gamma x_{\beta\gamma}) \subset z^{-1}(VC_\gamma x_{\beta\gamma}).$$

Since $0x \cap 0y \neq \emptyset$, we have (by (2) and (*)) that

$$y \in 0^{-1}(0x) \subset u^{-1}(Ux) \subset u^{-1}((Z^{-1}z)x) \subset (Zu)^{-1}(zx).$$

So there exists $z_1 \in Z$ such that

$$(4) \quad z_1uy = zx.$$

From (3) and (4) we get $z_1uy \in VC_\gamma x_{\beta\gamma}$ and, since $z_1u \in ZU \subset Z^2 = V$, we thus have

$$(5) \quad y \in V^{-1}(VC_\gamma x_{\beta\gamma}).$$

Hence (3) and (5) say that both x and y are in $V^{-1}(VC_\gamma x_{\beta\gamma})$. Consequently, recalling Lemma 4.3, if $\rho(y, C_\gamma x_{\beta\gamma}) < 1$ we get

$$|f_{\Gamma_1}(x) - f_{\Gamma_1}(y)| = |\rho(x, C_\gamma x_{\beta\gamma}) - \rho(y, C_\gamma x_{\beta\gamma})| \leq \rho(x, y) < \epsilon;$$

and if $\rho(y, C_\gamma x_{\beta\gamma}) \geq 1$, we get $f_{\Gamma_1}(y) = 0$ and

$$|f_{\Gamma_1}(x) - f_{\Gamma_1}(y)| = |1 - \rho(x, C_\gamma x_{\beta\gamma})| \leq |\rho(y, C_\gamma x_{\beta\gamma}) - \rho(x, C_\gamma x_{\beta\gamma})| \leq \rho(x, y) < \epsilon.$$

Therefore $0x \cap 0y \neq \emptyset$ and $f_{\Gamma_1}(x) \neq 0$ imply that $|f_{\Gamma_1}(x) - f_{\Gamma_1}(y)| < \epsilon$.

Now suppose $0x \cap 0y \neq \emptyset$ and $f_{\Gamma_1}(x) = 0$. If $f_{\Gamma_1}(y) = 0$, there is nothing to prove, while if $f_{\Gamma_1}(y) \neq 0$ then (as noted above) we can find $\eta \in \Gamma_1$, and suitable τ such that $\rho(y, C_\tau x_{\eta\tau}) < 1$; leading to

$$|f_{\Gamma_1}(x) - f_{\Gamma_1}(y)| = |1 - \rho(y, C_\tau x_{\eta\tau})| \leq \rho(x, y) < \epsilon.$$

Hence $0x \cap 0y \neq \emptyset$ implies $|f_{\Gamma_1}(x) - f_{\Gamma_1}(y)| \leq \epsilon(x, y \in S)$; and so $f_{\Gamma_1} \in LUC(S)$, by item 2.5(ii).

Next we consider the function $f_{\Gamma_1} \bullet f_{\Gamma_2}$ where Γ_1 and Γ_2 are given disjoint subsets of Γ . Suppose

$$(f_{\Gamma_1} \bullet f_{\Gamma_2})(x) = f_{\Gamma_1}(x)f_{\Gamma_2}(x) \neq 0 \text{ for some } x \in S.$$

Then one can find $\beta \in \Gamma_1$ and $\eta \in \Gamma_2$ such that

$$\rho(x, T_\beta) < 1 \text{ and } \rho(x, T_\eta) < 1.$$

This would lead to

$$(6) \quad x \in V^{-1}(VC_\gamma x_{\beta\gamma}) \cap V^{-1}(VC_\tau x_{\eta\tau})$$

for some γ and τ with $\beta \leq \gamma < \alpha$ and $\eta \leq \tau < \alpha$. But (6) contradicts Lemma 4.3. By this contradiction we conclude that the function $f_{\Gamma_1} \bullet f_{\Gamma_2}$ is identically equal to the zero function.

This completes our proof when S is a stip.

(b) Now we consider the case where $M_a(S)$ is non-zero. By [5, Chapter 2, Theorems 1.14 and 2.3] or [4], we can find a measure ν in $P_c(S) \cap M_a(S)$ such that the mapping $x \rightarrow \nu^* \delta_x$ of S into $M_a(S)$ is norm continuous. Let $D := \text{supp}(\nu)$ and note that D is compact.

We define $V := D^2$. By [4] or [5, Chapter 2, Lemma 1.9], we have $V^{-1}(Vx)$ a neighbourhood of x , for all $x \in S$. Hence, with our newly defined V , item (i) can be proved as done in case (a) and so we omit the details.

To prove (ii), we define the function f_{Γ_1} by

$$f_{\Gamma_1}(x) := \nu^* \delta_x(\overline{DT}_{(\Gamma_1)}) \quad (x \in S).$$

For any $x, y \in S$ we have that

$$\|_x(f_{\Gamma_1}) - _y(f_{\Gamma_1})\| \leq \|\nu^* \delta_x - \nu^* \delta_y\|$$

and so, by the norm continuity of the map $s \rightarrow \nu^* \delta_s$ of S into $M(S)$, we have $f_{\Gamma_1} \in LUC(S)$. It is also evident that $0 \leq f_{\Gamma_1} \leq 1$ and $f_{\Gamma_1} = 1$ on $\overline{T}_{(\Gamma_1)}$.

To complete the proof we now show that $f_{\Gamma_1} \bullet f_{\Gamma_2} = 0$ where $\Gamma_2 \subseteq \Gamma$ is disjoint from Γ_1 . To this end, suppose on the contrary there exists an x in S such that

$$f_{\Gamma_1}(x)f_{\Gamma_2}(x) > 0.$$

That $f_{\Gamma_1}(x) > 0$ means

$$\nu^* \delta_x(\overline{DT}_{(\Gamma_1)}) = \nu^* \delta_x(Dx \cap \overline{DT}_{(\Gamma_1)}) > 0,$$

since $\text{supp}(\nu^* \delta_x) = Dx$. By [4] or [5] (as similarly noted above) we have that $D^{-1}(D^2x)$ is a neighbourhood of Dx and so $D^{-1}(D^2x) \cap DT_{(\Gamma_1)} \neq \emptyset$ which implies that

$$(7) \quad x \in D^{-2}(D^2T_{(\Gamma_1)}) = V^{-1}(VT_{(\Gamma_1)}).$$

Similarly, that $f_{\Gamma_2}(x) > 0$ implies

$$(8) \quad x \in V^{-1}(VT_{(\Gamma_2)}).$$

By Lemma 4.3, we have

$V^{-1}(VT_{(\Gamma_1)}) \cap V^{-1}(VT_{(\Gamma_2)}) = \emptyset$ —contrary to (7) and (8). By this contradiction, we conclude that $f_{\Gamma_1} \bullet f_{\Gamma_2}$ is the zero function on S . ■

5 PROOF OF THEOREMS 3.1 AND 3.2

Throughout this section, S denotes a stip that is not relatively neo-compact.

5.1 PROOF OF THEOREM 3.1: We employ an argument along lines given in [9]. Let Γ be as stated in Lemma 4.4 and let U be the class of ultrafilters on Γ .

Corresponding to each $A \in U$ we claim that there exists a LIM on $LUC(S)$, m_A , such that

$$(1) \quad m_A(f_{\Gamma_1}) = 1 \text{ for every } \Gamma_1 \in A$$

where f_{Γ_1} is as in Lemma 4.4. To verify our claim, we first note that for each $\beta \in \Gamma$ we can find $m_\beta \in LIM(LUC(S))$ such that

$$m_\beta(f_{\{\beta\}}) = 1, \text{ by Lemmas 4.2 and 4.4.}$$

So for each $\Gamma_1 \in A$ we can choose $m_{\Gamma_1} \in LIM(LUC(S))$ (for example $m_{\Gamma_1} = m_\beta$ for any $\beta \in \Gamma_1$) such that

$$m_{\Gamma_1}(f_{\Gamma_1}) = 1.$$

Since $LIM(LUC(S))$ is a weak*-compact subset of $LUC(S)^*$, there exists a weak*-limit point, $m \in LIM(LUC(S))$, of the net $(m_{\Gamma_1})_{\Gamma_1 \in A}$, where the ordering on A is backwards inclusion. One can easily note that m satisfies (1) and so we take $m_A := m$ and our claim is proved.

Next we show that, for distinct ultrafilters A_1 and A_2 in U , we have $m_{A_1} \neq m_{A_2}$. To this end, fix disjoint subsets Γ_1 and Γ_2 of Γ with $\Gamma_1 \in A_1$ and $\Gamma_2 \in A_2$. Let f_{Γ_1} and f_{Γ_2} be as in Lemma 4.4 and note that $0 \leq f_{\Gamma_1} + f_{\Gamma_2} \leq 1$. So item (1) and Lemma 4.4 (ii) give

$$1 \geq m_{A_1}(f_{\Gamma_1} + f_{\Gamma_2}) = m_{A_1}(f_{\Gamma_1}) + m_{A_1}(f_{\Gamma_2}) = 1 + m_{A_1}(f_{\Gamma_2})$$

and so $m_{A_1}(f_{\Gamma_2}) = 0$, while $m_{A_2}(f_{\Gamma_2}) = 1$.

It follows that $\text{card}(\text{LIM}(LUC(S))) \geq \text{card}(U)$. It is well-known that $\text{card}(U) \geq 2^{2^{|\Gamma|}}$ (see for example [7]). As $|\Gamma| = d(S)$, we have

$$\text{card}(\text{LIM}(LUC(S))) \geq 2^{2^{d(S)}}.$$

■

5.2 PROOF OF THEOREM 3.2: (i) By Theorem 3.1 we only need to show that

$$\text{card}(\text{LIM}(LUC(S))) \leq 2^{b(S)}.$$

First we consider the case where the identity or S is δ -isolated. By [14] or [15, Chapter 3, Proposition 3.8(i)] we can find a compact subgroup G of S such that every compact subset C of S contains a countable subset B_C such that

$$C \subseteq \overline{GB_C}.$$

Let π be normalised Haar measure on G and define the space

$$N(S) := \{\pi of : f \in LUC(S)\}.$$

For $g \in G$ and $b \in B_C$, we have (by invariance of π)

$$\pi of(gb) = \pi of(b).$$

So each function in $N(S)$ is uniquely determined by its value on

$$B := \cup\{B_{C_\gamma} : 1 \leq \gamma < \alpha^1\}$$

where α^1 is the smallest ordinal having cardinality $b(S)$ and $\{C_\gamma : 1 \leq \gamma < \alpha^1\}$ is a covering of S by compact sets. Hence

$$|B| \leq \aleph_0 \bullet b(S) = b(S).$$

Therefore

$$|N(S)| \leq c^{|B|} \leq c^{b(S)} = 2^{b(S)}$$

and

$$(1) \quad |N(S)^*| \leq 2^{2^{b(S)}}.$$

Now for each $m \in LIM(LUC(S))$, we have that m is a *TLIM* by [5, Chapter 4, Lemma 2.3], and so

$$m(f) = m(\pi of) \quad (f \in LUC(S)).$$

Thus m can be viewed as an element of $N(S)^*$ and, recalling (1), we get

$$\text{card}(LIM(LUC(S))) \leq \text{card}(N(S)^*) \leq 2^{2^{b(S)}}.$$

For the case where S is commutative, let e be a δ -isolated idempotent and note that $m \in LIM(LUC(S))$ gives $m \in LIM(LUC(eSe))$ since ${}_e f_e = {}_e f$ and $m({}_e f) = m(f)$. Since eSe is a stip (see [5] or [13]) with δ -isolated identity e , our result follows from the above argument.

(ii) If S is σ -compact, by [13] or [5, Chapter 3, Lemma 3.4] we can find $x \in S$ and a δ -isolated idempotent, e , such that

$$xS \subset eSe$$

and so each $m \in LIM(LUC(S))$ gives rise to $m \in LIM(LUC(eSe))$, leading to

$$\text{card}(LIM(LUC(S))) \leq 2^{2^{b(S)}}$$

as noted above.

Recalling (i) and Proposition 2.2, our result follows. ■

6 PROOF OF THEOREM 3.3 AND COROLLARIES 3.4 AND 3.5

6.1 PROOF OF THEOREM 3.3: (i) The proof of Theorem 3.1 gives

$$\text{card}(LIM(LUC(S))) \geq 2^{2^{d(S)}}$$

for our present semigroup S , and so we omit details.

To show that $\text{card}(LIM(LUC(S))) \leq 2^{2^{b(S)}}$ we first develop a background that would enable one to argue in a similar manner to the proof of Theorem 3.2(i). By [4] or [5], we can find a measure ν in $P_c(S) \cap M_a(S)$ such that the mapping $x \rightarrow \nu^* \delta_x$ of

S into $M(S)$ is norm continuous. Hence each compact subset C contains a countable subset B_C such that

$$\{\nu^*\delta_x : x \in C\} \subseteq \text{closure}\{\nu^*\delta_x : x \in B_C\}.$$

Consequently, noting that $\nu of(x) = \nu^*\delta_x(f)$, we have for all $f \in LUC(S)$,

$$(1) \quad \{\nu of(x) : x \in C\} \subseteq \text{closure}\{\nu of(x) : x \in B_C\},$$

Let

$$N(S) := \{\nu of : f \in LUC(S)\}$$

and note that $m(\nu of) = m(f)$ for all $f \in LUC(S)$ and $m \in LIM(LUC(S))$. With this and (1) in mind, the reader can mimic the argument in the proof of Theorem 3.2(i) to complete the proof.

(ii) Note that for $h \in M(S)^*$ and ν as in the proof of (i), νoh , viewed as a function on S (given by $\nu oh(x) = \nu oh(\delta_x)$) is in $LUC(S)$ since

$$\|_x(\nu oh) - _y(\nu oh)\| \leq \|h\| \|\nu^*\delta_x - \nu^*\delta_y\| \quad (x, y \in S).$$

So each $TLIM$ on $M(S)^*$ can be viewed as a LIM on $LUC(S)$ and hence

$$\text{card}(TLIM(M(S)^*)) \leq 2^{2^{b(S)}}$$

by (i). Also the proof of Theorem 3.1 can be mildly amended to give

$$\text{card}(TLIM(M(S)^*)) \geq 2^{2^{d(S)}},$$

by using Lemma 4.1 in place of 4.2 and replacing the functions $f_{\Gamma_1} \in LUC(S)$ by functionals $f_{\Gamma_1} \in M(S)^*$ given by $f_{\Gamma_1}(\mu) := \mu(\overline{T}_{(\Gamma_1)})$ for all $\mu \in M(S)$. (We omit the details.)

Recalling Proposition 2.2, the proof of our Theorem is complete. ■

6.2 PROOF OF COROLLARY 3.4: By restriction each $TLIM$ on $M(S)^*$ gives rise to a $TLIM$ on $M_a(S)^*$ and on $LUC(S)$. By [5, Chapter 4, Theorem 2.4] each LIM on $LUC(S)$ gives rise to a $TLIM$ on $M(S)^*$. With this in mind, the result follows from Theorem 3.3. ■

6.3 PROOF OF COROLLARY 3.5: Recalling that $M_a(G)$ is identifiable with $L(G)$ and hence $M_a(G)^*$ with $L^\infty(G)$ —see for example [8], the result is a special case of Corollary 3.4. ■

7 PROOF OF THEOREM 3.6

Since S is σ -compact, we have $b(S) = d(S) = \aleph_0$ and the sets C_γ mentioned in Lemma 4.3 can thus be chosen to be compact, giving σ -compact sets T_β for $1 \leq \beta < \infty$. Hence mimicing the proof of Theorem 3.1, using Lemma 4.1 in place of 4.2 and replacing functions f_{Γ_1} by functionals given by $f_{\Gamma_1}(\mu) := \mu(T_{(\Gamma_1)})$ for all $\mu \in M(S)$ and $\Gamma_1 \subset \Gamma$, we get

$$\text{card}(TLIM(M(S)^*)) \geq 2^{2^{d(S)}} = 2^{2^{\aleph_0}} = 2^c.$$

(We omit details.) ■

8 SOME REMARKS

8.1. As noted in 2.4, interest in stips arose from the fact that every locally compact topological semigroup, S , with an identity element and coinciding with the foundation of $M_a(S)$, is a stip. However, it is still not known whether every stip supports an absolutely continuous measure—see [5] and [13]. Recently a number of studies have shown that many results one can obtain for locally compact topological semigroups supporting absolutely continuous measures remain valid for stips—see for example [5, Chapter 3, Section 4] and [14]. To some extent out Theorems 3.1 and 3.2 belong to the same sphere.

8.2. We strongly believe that Theorem 3.2(i) holds for all stips. A reader interested in persuing this problem may find the studies in [5] and [13] of some use.

8.3. There are many semigroups satisfying the hypothesis of Theorem 3.6 which are not stips and do not support absolutely continuous measures. One simple example is $S := [0, \infty)$ with the relative line topology and maximum operation. We also feel that Theorem 3.6 may be extendable to left invariant means on left uniformly continuous functions as follows:

CONJECTURE. *If S is a C -distinguished topological semigroup that is σ -compact but not relatively neo-compact, and such that $LUC(S)$ admits a left invariant mean, then*

$$\text{card}(LIM(LUC(S))) \geq 2^c.$$
