The Reign of Henry the Fifth. Volume I (1413-1415). By James Hamilton Wylie, M.A., D.Litt., late H.M. Divisional Inspector of Schools. Ford's Lecturer in the University of Oxford, 1899.

Royal 8vo. pp. viii + 560. Price 253. net

"The publication of the first volume of Dr Wylie's projected History of the Reign of Henry V," says *The Morning Post*, "has been almost immediately followed by the announcement of his death, at the age of sixty-nine. Dr Wylie spent nearly forty years in the service of the Board of Education, and, after his retirement in 1909, he was appointed an Inspector of Historical MSS. The research which has made his name familiar to historical students...was therefore the work and amusement of the leisure hours of a busy man; yet he succeeded in acquiring an amount of historical learning which would have done credit to a student whose whole life was devoted to his subject."

This book is a continuation of the History of England under Henry IV, by the same author, which was published in 1898, and the present volume carries the story to the point at which the first expedition sailed for Harfleur.

The first edition was published in 1896, and was at once recognised as a work indispensable to the study of the history of the 17th century and of Political Theory in general. The author explains that while the historical account stands mainly as before, his opinions on the theory of Sovereignty, the relation of Small Groups to the State, and other political problems have undergone much change.

The additional essays are entitled: "*Aaron's Rod Blossoming* or *Jus Divinum in* 1646," "Erastus and Erastianism," and "Bartolus and the Development of European Political Ideas."

Each indigenous species of flowering plants, many naturalised species and many varieties and *formae* will be illustrated from the pen-andink drawings of British flowering plants which have recently been presented to the University of Cambridge by Mr E. W. Hunnybun. Each plant or portion selected has been drawn natural size, and will be reproduced without reduction or enlargement. In addition to the main drawing of each plant, there are also enlarged drawings of critical organs. Each drawing has been made by Mr Hunnybun from a fresh plant, the name of which has been vouched for by some competent authority whose letter of identification is preserved in the Cambridge University Herbarium. Such a set of drawings is quite unique in the history of botany. The high artistic merit and scientific value of the drawings are admitted by all who have seen them.

The Flora will be written by Dr C. E. Moss, Curator of the Cambridge University Herbarium. Engler's system of classification will, generally speaking, be followed. This system is becoming very generally adopted: already there are German, Swiss, American and other Floras based upon it.

The systematic descriptions will be in English, not in Latin; and the geographical distribution of important groups will be fully stated. Distribution-maps will be freely provided.

The critical elucidation of the more difficult genera will receive careful attention. A large number of botanists have kindly promised their aid, and, in order to keep a uniform standard of treatment, Dr Moss will act as Editor of the genera treated by the various specialists. Volume II is now ready.

This Volume deals with the earlier Dicotyledonous families, and thus includes most British trees, such as Poplars, Willows, Birches, Oaks and Elms, as well as Docks, Goosefoots and Glassworts. It contains an important contribution by the Rev. E. S. Marshall on Birches.

The Conifers, Ferns and Horsetails, and perhaps, also, the Liverworts, Mosses and Stoneworts, will be included in Volume I. Volume III will, it is hoped, be published in 1915, and will contain the Pinks, Buttercups and Poppies. The order of the appearance of the remaining volumes will be announced in due course.

THE GOSPELS—CANTICLES—NESTORIUS

The Fourfold Gospel. Section II: The Beginning. By Edwin A. Abbott, Honorary Fellow of St John's College, Cambridge. Fellow of the British Academy.

Demy 8vo. pp. xxiv+456. Price 125. 6d. net

The present volume deals with the antecedents, acts, and words of John the Baptist, and the relations between John and Jesus up to the time when Jesus came into Galilee "after John had been delivered up."

"Dr Abbott's work always bears the mark of high distinction. He gives us much in the way of instruction and stimulus which we scarcely expect to find in any other writer....An investigation like this of Dr Abbott's is, apart from the value of its particular conclusions, a new revelation of the fascination which a minute study of the Gospels can bring to the reader, a revelation, too, of the rich possibilities which such study bears. A careful reader of Dr Abbott's pages will receive a great enrichment of knowledge; but he will also gain what is still more valuable, an incentive to exact study and something like a new equipment for the interpretation of Gospel history."— The Westminster Gazette

The Canticles of the Christian Church, Eastern and Western, in Early and Medieval Times. By James Mearns, M.A., Vicar of Rushden, Buntingford.

Demy 8vo. pp. x+106. With 3 plates. Price 6s. net

This volume is believed to be the first attempt, in any language, to cover the whole field of investigation. It is based throughout upon the manuscripts, and the collection and classification of the materials has been the work of several years.

Part I deals with the *Greek and Eastern Canticles* under the headings of Greek, Graeco-Latin, Arabic, Armenian, Coptic, Ethiopic, Georgian, Persian, Slavonic, and Syriac. Part II with *Latin and Western Canticles*.

Reproductions of three MSS are included in the book, together with Indexes of Canticles and of MSS cited.

Nestorius and his place in the History of Christian Doctrine. By Friedrich Loofs, D.D., Phil.D., Professor of Church History in the University of Halle-Wittenberg, Germany.

Crown 8vo. pp. viii+132. Price 3s. 6d. net

The book consists of four lectures which the author was invited to give last year at London University; they are entitled: I. A Fresh Interest in Nestorius Recently Awakened. II. The Tragedy of Nestorius' Life. III. The Doctrine of Nestorius. IV. Nestorius' place in the History of Christian Doctrine.

"The recent discovery of Nestorius' *Liber Heraclidis* has awakened a new interest in a theologian not hitherto much regarded by modern historians, and for orthodox churchmen condemned as a heretic who saw in Christ no more than an inspired man. Dr Loofs, in his learned and well-reasoned study, sets out to show that this is not a tenable theory of the doctrine of Nestorius."—The Scotsman

THE MODERN BIBLE—THE POEM OF JOB

The Bible of To-Day. By the Rev. Alban Blakiston, M.A.

Large Crown 8vo. pp. xvi+240. Price 3s. net

In this book an attempt is made "to introduce the student of the Bible to what is known as the historical, or critical, method of studying the Scriptures and investigating their messages. The volume does not aim at supplying introductions to the separate books....The purpose is, rather, to present to the reader the point of view which is responsible for applying the historical method of treatment to the sacred pages, and to envisage the 'atmosphere,' intellectual and religious, which is the outcome of that treatment....

In an introductory chapter the question of Inspiration is briefly discussed. The second chapter deals with the Text of the Old Testament, and seeks to trace, in outline, the history of its different writings; endeavouring to grasp, on the one hand, what were the causes which determined their form and contents; and, on the other hand, how they came to be combined in a single volume to which a peculiar sanctity was attached. The third chapter deals with the New Testament upon similar lines. And, in the last chapter, it is attempted to show what were the influences which contributed to the development of the Jewish and Christian religions, in so far as the books of the Old and New Testaments exhibit this sort of dependence. Incidentally a great many other subjects are touched upon."

The Poem of Job, translated in the metre of the Original. By Edward G. King, D.D., Sidney Sussex College, Cambridge.

Pott 4to. Paper boards, parchment back. pp. xii+116. Price 5s. net

The system of translating Hebrew poetry according to the principle of accented syllables the author has previously explained in his volume on *Early Religious Poetry of the Hebrews* in the series of Cambridge Manuals. "It appears to me," he says, "that the English language well lends itself to this rhythm, and that much of the beauty of our Bible Version is due to the fact that the translators, from time to time, fall into it, all unconsciously; e.g. Job iii. 19:

'The small and great are there;

And the sérvant is frée from his máster.'

Here, as in Hebrew, the rhythm depends not on the number of syllables but on the beat of the accent."

The Bacteriological Examination of Food and Water. By William G. Savage, B.Sc., M.D. (Lond.), D.P.H. County Medical Officer of Health, Somerset. Late Lecturer on Bac-

The author feels that existing textbooks upon Bacteriology, lucid and complete as they are, are concerned chiefly with the pathological aspect; whereas the treatment given to the bacteriological examination of water, air, foods, and the like is commonly inadequate. "The aim of this volume is to remedy this defect and to make available a practical manual dealing not only with the examination of these substances but also with the deductions to be drawn from the bacteriological data obtained from their examination. of the available information Much is only at present to be found in original papers not always readily ac-cessible."

Lectures on Dryden. Delivered by A. W. Verrall, Litt.D., King Edwara VII Professor of English Literature and Fellow of Trinity College, Cambridge. Edited by Margaret De G. Verrall.

"In October and November 1911, Dr Verrall, as King Edward VII Professor of English Literature, delivered a course of twelve lectures on Dryden, thus carrying out the intention which he formed as soon as he was appointed to the English Chair. The reason for the selection of this subject was not only his own long-standing admiration for Dryden, but the importance of his work in the development of English prose and verse, and its comparative neglect among the younger lovers of literature at the present day....The present volume reproduces strictly the original manuscript notes as arranged for delivery."—*Preface*

"This work," says the author in his Preface, "was written as part of a History of Roman Private Law, which I can scarcely hope to complete, but for which I have been collecting notes and other materials during many years. It is therefore intended primarily for readers who take the study of Roman Law with Jurisprudence, and necessarily involves some considerable acquaintance with the former subject. It does not affect to be a Manual, being intended rather for students than candidates for examination."

The Glasgow Herald describes the book as an "elaborate, erudite, and leisurely examination of the nature of jurisprudence under constant reference to the Roman Law and the English institutional writers, at once analytical, descriptive, and comparative. If it has little of the formal precision of Holland's well-known text-book, its discursive method admits of wise and full discussion of such problems as the relation of morality to law, and of law to the state, which are of immediate interest to many other persons than students."

Greek Sculpture and Modern Art. By Sir Charles Waldstein, Litt.D., Ph.D., L.H.D. Fellow and Lecturer of King's College, Cambridge. Sometime Slade Professor of Fine Art, Reader in Classical Archaeology, Director of the Fitzwilliam Museum, Cambridge, and Director of the American School of Archaeology, Athens.

Demy 8vo. pp. xii+70. With 78 plates. Price 7s. 6d. net

The book comprises two lectures, delivered by the author in February 1913 to the students of the Royal Academy Art School; these are now

published in a more permanent form, as it is thought that they will prove useful, not only to students of art, but also to the general public, as an introduction to the study of sculpture. The author's aim has been to show that "whatever justification there be in the new aspirations, in the new methods, and in the new outlook, the study of Greek sculpture still remains, and will always remain, as far as its fundamental principles and its main achievements are concerned, a subject which you can study with profit and at some stage you must study."

The author's allusions to the famous examples of both ancient and modern art are illustrated by a very large number of photographs. "These," says The Times, "are judiciously selected, and the text supplied is helpful; ...the book will be a welcome addition to the libraries of those to whom Greek art is a source of undying joy."

As an Appendix, Sir Charles Waldstein reprints a leading article which appeared in The*Times* on the subject of his lectures, and his own reply to some criticisms which it contained.

DYNAMICS-PHOTO-ELECTRICITY

Dynamics. By Horace Lamb, Sc.D., LL.D., F.R.S. Formerly Fellow of Trinity College, Cambridge. Professor of Mathematics in the Victoria University of Manchester.

Demy 8vo. pp. xii+344. Price 105. 6d. net

In dealing with his subject the author, avoiding the abstract treatment, which he regards as "likely to bewilder rather than to assist the student," has preferred to follow the method adopted by Maxwell in his *Matter and Motion*. Some account of the more abstract, if more logical, way of looking at dynamical questions is given at the end of the book. The author has been at pains to collect useful examples for practice, preference having been given to those which are simple rather than elaborate from the analytical point of view.

Such an account is attempted in this book, all forms of ionisation by light being considered, whether in solids, liquids or gases.—*Extract from the Preface*

THE RESPIRATORY FUNCTION OF THE BLOOD

The Respiratory Function of the Blood. By Joseph Barcroft, M.A., B.Sc., F.R.S. Fellow of King's College, Cambridge.

Royal 8vo. pp. x+320. With a plate and 156 text-figures. Price 18s. net

"At one time," says the author, "most of my leisure was spent in boats. In them I learned what little I know of research, not of technique or of physiology, but of the qualities essential to those who would venture

beyond the visible horizon. The story or my physiological 'ventures' will be found in the following pages."

The book is divided into three parts—I. The Chemistry of Haemoglobin, II. The Passage of Oxygen to and from the Blood, III. The Dissociation Curve considered as an "Indicator" of the "Reaction" of the Blood. A specially interesting portion is that which deals with the effect of exercise and of altitude on the action of the blood.

"The investigation of the respiratory function of the blood is one of the most difficult and yet one of the most interesting lines of physiological research, and Dr Barcroft's volume is worthy of the subject. His work along these lines is already well known, but the issue of it in book form is a welcome addition to the literature of the subject....The volume is more than a mere chronicle of experiments performed by the author and his colleagues, though considered from this aspect alone the results are indeed valuable. Plastics,' regarded by the author as the chief treatise of the four, has never previously been published. The definite grouping of these various treatises in the form of a single work, as intended when written, is also here first made known."

"Dr Rand has been a faithful servant to the memory of Shaftesbury. It was he who, in 1900, discovered at the Record Office the treatise called 'Philosophical Regimen,' and published his discovery. The object of the present work is to bridge the gulf which lies between these two periods.

Naval officers are brought into frequent contact with oversea trade, not only in arranging for the supply of fleets and naval bases in time of peace, but in the attack on, and defence of, commerce in time of war; to his summary, therefore, of the process of ocean trade in times of peace the author has added some reflections on the situation created by a sudden outbreak of war.

THEOLOGY

Joshua: The Hebrew and Greek Texts. By S. Holmes, M.A., Lecturer in Theology, Jesus College, Oxford, and formerly Senior Kennicott Scholar. Demy 8vo. pp. viii + 80. Price 7s. net.

The result of Hollenberg's enquiry into the texts of the Book of Joshua in 1876 was in many passages favourable to the LXX; he strongly denies deliberate alteration but on the whole seems to uphold the general superiority of the M.T.

Ten years later a far less favourable attitude was adopted by the great scholar Dillmann; he affirms that the value of LXX, in this book as well as in others, has been much overestimated. Other scholars have given their support to this view, and Holzinger (1901) explicitly affirms that the statement of Dillmann—that LXX does not offer a more original text, but represents in many cases a deliberate endeavour to avoid difficulties—still holds good.

The present thesis dissents from this position and offers some fresh reasons in favour of the superiority of the LXX :

(1) The phenomenon of double and sometimes more frequent omission of the same word or expression in LXX in a large number of passages.

(2) The circumstance that in several cases where the two texts vary from one another, each text is consistent with itself; thus suggesting the hypothesis of a deliberate and systematic revision.

(3) The fact that the confused LXX passage, ch. v. vv. 4 f., when turned back into Hebrew requires only a slight emendation to give an intelligible text manifestly earlier than M.T.

Evolution and the Need of Atonement. By Stewart A. McDowall, M.A., Trinity College, Cambridge, Assistant Master at Winchester College. Crown 8vo. pp. xx + 184. Price 4s. 6d. net.

A second edition, revised and enlarged. The author addresses his work to those who are oppressed with the difficulties of their faith not as an apologetic, but as a restatement of certain fundamental doctrines of Christianity from that point of view which the spirit of the age forces upon us. In the new edition a considerable section has been added to the discussion of original sin, and the treatment of the Atonement itself has been amplified by a new chapter linking the two portions of the book more closely.

FORTHCOMING BOOKS

Volume XI of *The Cambridge History of English Literature* will be ready shortly. It will deal with the writers of the closing years of the eighteenth century, and the early years of the nineteenth, notably the poets and politicians who were influenced by the French Revolution— Wordsworth, Coleridge, Burke. It will also contain sections devoted to Burns, Cowper, Crabbe, Blake, Bentham, Southey.

The Life, Letters and Labours of Francis Galton has been compiled by Professor Karl Pearson, Director of the Galton Laboratory, and the former friend and colleague of the great scientist. The work will be complete in 2 volumes, of which the first will be ready shortly.

Clio Enthroned, by Mr W. R. M. Lamb, deals with Thucydides his style and the literary influences under which his work was composed. The writer emphasises the view that the aim of Thucydides was not merely to produce a truthful document, but to set the Muse of history upon her rightful throne.

The Philosophy of Biology, by Dr James Johnstone, is described by the author as "an attempt to understand the descriptions of the Science in the light of its later investigations"; the point of view and the methods of treatment adopted by him are those suggested by Driesch and Bergson.

Professor E. J. Rapson's work on *Ancient India* is written in a manner intelligible to all who take an interest in Modern India, and contains an outline of the history of the national, religious, and social systems of India which flourished between 1200 B.C. and the first century A.D. Two maps are included, together with several photographs of ancient monuments and inscriptions.

In Professor E. G. Browne's new book on *The Press and Poetry of Modern Persia*, the first part will contain a complete list of Persian newspapers, with particulars concerning each, whilst the second part will consist of specimens of the political and patriotic poetry of Modern Persia.

The six hundredth anniversary of the Battle of *Bannockburn* will be celebrated in June of this year, and the Press will shortly publish a work by Dr J. E. Morris in which the story of the battle is re-told in the light of recent investigations into the site of the struggle, the number of men engaged, and so on. The book will be illustrated by plans and photographs. The same author has written a *Modern History of Europe from* 1558 for school use, which will also be ready shortly.

Dr J. R. Clark Hall, author of a prose translation of *Beowulf*, has now made a metrical translation of the same poem into modern English, in which he attempts to get as close as possible to the rhythm of the

original and at the same time to make the rendering acceptable to those who are unfamiliar with the peculiar structure of Old English verse.

A book on *English Folk-Song and Dance*, by Mr Frank Kidson and Miss Mary Neal, should be of special interest in view of the recent efforts which have been just in time to rescue a valuable, but rapidly disappearing, national inheritance, and which are now giving it a renewed vigour in the life of the people.

Perception, Physics, and Reality, by Mr C. D. Broad, Fellow of Trinity College, is an enquiry into the information that Physical Science can supply about the Real.

Philosophy: What is it? by Dr F. B. Jevons, consists of five lectures delivered before a branch of the Workers' Educational Association which had expressed a desire to know what Philosophy is; the truth, implied in this request, that Philosophy is the concern of the average man and of practical life is one which this book seeks to emphasise.

The British Revolution, by Dr R. A. P. Hill, deals with the political problems of the moment from the philosophical standpoint. The author seeks to show that Theory, so commonly the suspect of practical men, "is a draught-horse and will drag a load."

Pragmatism and French Voluntarism, by Miss L. S. Stebbing, is an essay written with especial reference to the notion of Truth in the development of French Philosophy from Maine de Biran to Prof. Bergson.

Dr F. R. Montgomery Hitchcock has written a study of the teaching of *Irenaeus of Lugdunum*.

A book on *Elementary Logic* by Mr Alfred Sidgwick gives some account, for beginners, of both the old system and the new in the study of this subject : i.e. it treats Logic (1) as a carefully limited subject to get up for an examination, and (2) as a free study of some of the chief risks of error in reasoning.

Dr A. R. Forsyth's lectures delivered before the University of Calcutta during January and February 1913, will be published under the title of Lectures introductory to the Theory of Functions of Two Complex Variables.

A second edition of Volume I of Dr A. Russell's *Theory of Alternating Currents* will shortly be published in the *Cambridge Physical Series*. Besides many additions to the earlier chapters, four new chapters have been added to the book, including one on High Frequency Currents.

Dr Hobson's lecture on *John Napier, and the Invention of Logarithms*, 1614, commemorates the tercentenary of the publication of John Napier's work which embodied this great discovery.
