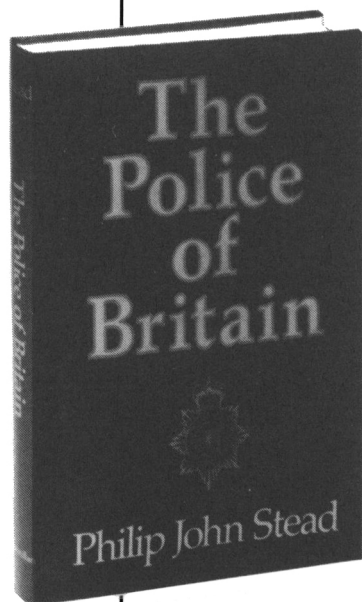


## **Atlas of the English Civil War**
