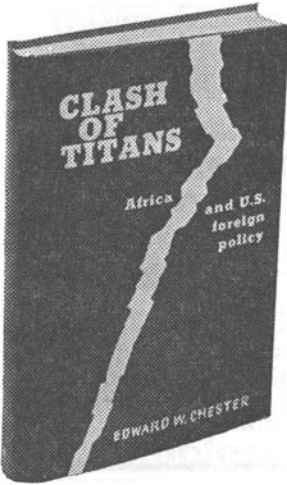

The most striking features are the passages leading down to the outwork and the sea front, and a collection of sketches of ships and other subjects on the plastered wall of one of the bastions. 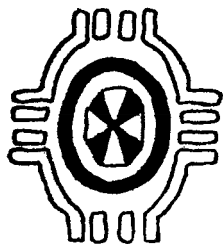

IGBO POLITICAL CULTURE

In an attempt to provide a primary source for the study of Igbo political culture, the author of this work, himself an Igbo, uses a participatory research method which, combined with his familiarity with the academic literature, results in a unique depiction of the internal structure and patterns of Igbo society. The Igbo political system is viewed in terms of the cultural content of political institutions, the interaction of religion with political processes, and the nature of political values. Professor Njaka's research rests on oral rather than written interviews, and on field work rather than library research.

This book examines the administrative, political and socio-economic problems which faced Africans in taking over the complex governmental machinery of Nairobi—one of the most important cities of East Africa. The author develops a theoretical framework to analyze the functioning of local government in developing countries and then discusses the relationship of the central and local governments, resource allocation at the local level, the bureaucracy, and the impact of decolonization, concluding with studies of two critical areas of governmental functioning—public housing and citizen participation.
