University of Alabama Cooperates in Educational Improvement Programs

The latest project of improvement of education in Latin American schools pursued by the University of Alabama College of Education is a program of cooperation with three binational schools in Ecuador. The five-year program of teacher education and improvement services includes in-service education for teachers in the participating schools, educational consultation for upgrading the school curricula, providing for graduate degrees and certification for the teachers, and developing professional guides and reports aimed at resolving persistent problems faced by the schools. Similar programs have been developed for schools in Colombia, the Dominican Republic, and Haiti by the university. Information is available from the project director, Paul G. B.O.L.S.A. Establishes Publications Fund

The Bank of London & South America, Ltd., has established a trust fund to encourage and assist the study of Latin American affairs by financing the publication of original studies in economic, political, social, and cultural fields. Brazilian Center of Demographic Study Created

Within the Instituto Brasileiro de Estatístico, the Centro Brasileiro de Estudos Demográficos was created to pursue research on population, coordinate

Center of Amazonian Social and Cultural Studies Organized

In 1968, the Department of Anthropology of the Museo Paraense "Emilio Goeldi" enlarged its field of activities through the organization of the Centro de Estudos Socias e Culturais da Amazônia (CESCA). Under the direction of Eduardo Galvão, the center has as its purposes the training of professional personnel in regional development and the pursuit of research on the area. CESCA cooperates in some projects with the area development agency, Superintendency of Amazonian Development (SUDAM). A major task during the first year of operations for CESCA was the sponsorship of an intensive course, conducted from July to December 1968, in social research on Amazonia; some 30 post-graduate students from the University of Pará and government institutions were participants. Curriculum and Resources on Andean Countries Strengthened at University of Pittsburgh

The University of Pittsburgh's Center for International Studies is supporting a program which involves faculty members, representing different disciplines, specialists in Andean studies, who have formed a group to identify and provide a focus for their common interests. The group, coordinated by Cole Blasier, will assess possibilities for strengthening curriculum and library resources on the countries of Bolivia, Ecuador, and Peru, and will prepare a proposal in the field of Andean studies to be submitted to the U. Linguistics Section of Mexico's National Anthropological Museum Reports

The Sección de Lingüística was created in 1968 within the Museo Nacional de Antropología by the Instituto Nacional de Antropología e Historia of Mexico. Under the directorship of Leonardo Manrique Casteñeda, the section has developed a program of research and working projects. The purposes served by the section include: enlarging the collections of the museum concerning pre-Hispanic and disappearing languages, through formation of archives of materials on the structure and use of the various dialects; pursuing research of the material accumulated; and organizing and conserving the tapes, pre-Hispanic writings, colonial maps and materials, and exhibited materials with which the section is charged. The section is currently preparing maps of geographic distribution and density of languages and illustrative materials on functions, variety, evolution, and history of language for permanent exhibition in the museum. Temporary exhibitions are also being prepared on such subjects as Maya writing, reconstruction of the proto-Mixtecan culture, and the Tarascan language.
