

**DIRECTOR**  
**CENSUS OF CANADA**

The Dominion Bureau of Statistics seeks a person for the important and challenging position of Director of the Census Division. This Division is being substantially expanded to meet intensified demands for statistics of population, housing and agriculture, required for planning and research activities in both the private and public sectors, and to enable the development and application of modern techniques of census taking and the analysis of census results. The successful applicant will be responsible for directing a large professional and support staff engaged in planning, organizing and taking censuses; and the compilation, analysis and publication of census results. He will be called upon to plan and co-ordinate programs of research and experimentation designed to improve census methodology and the quality and usefulness of census statistics. One of the principal responsibilities of the Director will be maintaining effective contact with all levels of government, universities and other major census users, to ensure that the statistics produced are the most useful.

*Qualifications*

The successful applicant will be a University graduate and is likely to have had senior responsibility for teaching, research or operational activities in one of the social sciences. He will have a good knowledge of demography or closely related fields, and a thorough appreciation of statistical systems. He will likely have done economic or social research and will have demonstrated administrative and leadership competence of a high order. A knowledge of both English and French would be an asset.
