

Dojo Magic and Exorcism in Modern Japan

Winston Davis. This is a study of Sukyo Mahikari (True-Light Supra-Religious Organization), an exorcistic sect in Japan, whose teachings attribute illness and misfortune to evil spirits. By casting out these spirits, members are able to cure diseases, repair broken television sets, change the weather, and bring dead goldfish back to life. The author combines ethnographic description and theoretical analysis to trace the history, teachings, and practices of the sect and to assess its impact on the lives and attitudes of members. A Tale of Flowering Fortunes

Annals of Japanese Aristocratic Life in the Heian Period

Translated with an Introduction and Notes, by William H. & Helen Craig McCullough. A Tale of Flowering Fortunes is the first translation into a Western language of Eiga monogatari, an eleventh-century chronicle of Japanese court life from the middle of the tenth century to the death of the famous Fujiwara Regent Michinaga in 1028. It is one of the most important sources available to social historians of the period, complementing the fictional portrait of the society drawn in *The Tale* of Genji. Marriage and Adoption in China 1845-1945

Arthur P. Wolf & Chieh-shan Huang. Based on a detailed analysis of Japanese household registers for an area of the Taipei Basin, this study makes two general points. One is that the choice between minor, major, and uxorilocal marriage can only be understood in the context of economic options and demographic changes. The other, bringing in data from other parts of Taiwan and from the Chinese mainland, is that Chinese family organization varied sharply from region to region, to the point where forms of marriage that were nearly unknown in one region were actively preferred in another. \$18.95

Revolution and Tradition in Tientsin, 1949-1952

Kenneth G. Lieberthal. Tientsin, China's second-largest industrial and commercial center, was the first of the major treaty ports to come under Communist rule in 1949. With its mixture of traditional China and the modern West, it presented a complex challenge to the new regime. This book uses an analysis of how the Communists expanded and consolidated their power in Tientsin to illuminate several fundamental issues confronting the PRC then and now: How is political consciousness shaped? What are the social bases of anti-Communism in urban China? And most important, can mass mobilization be used more effectively than organizational control to produce lasting changes in attitudes and social practices? \$18.50

Certain to be the standard reference work on the subject, this comprehensive political and statistical analysis treats all aspects of China's energy development and foreign energy policy. Part I describes, analyzes, and projects the course of China's international energy relations from 1949 through the year 2000. Part II presents a detailed, coordinated set of energy balance statistics and nearly 100 statistical tables that give data for the resource, production, consumption, and trade stages of each energy industry, with projected statistics to the year 2000. Mao Tse-tung, Ch'en Po-ta, and the Search for Chinese Theory, 1935–1945

Raymond F. Wylie. This study investigates the political and ideological context of Mao's rise to power in the Chinese Communist Party, and in particular the development of the political ideology known as "Mao Tse-tung's thought." The author's analysis of the complex interplay of elite politics within the CCP falls into two main periods: 1935–40, when the basic ideas behind the Chinese brand of Marxism were worked out by Mao and Ch'en; and 1940–45, when the two men worked to systematize and disseminate Mao's thought as the CCP's official guiding doctrine.
