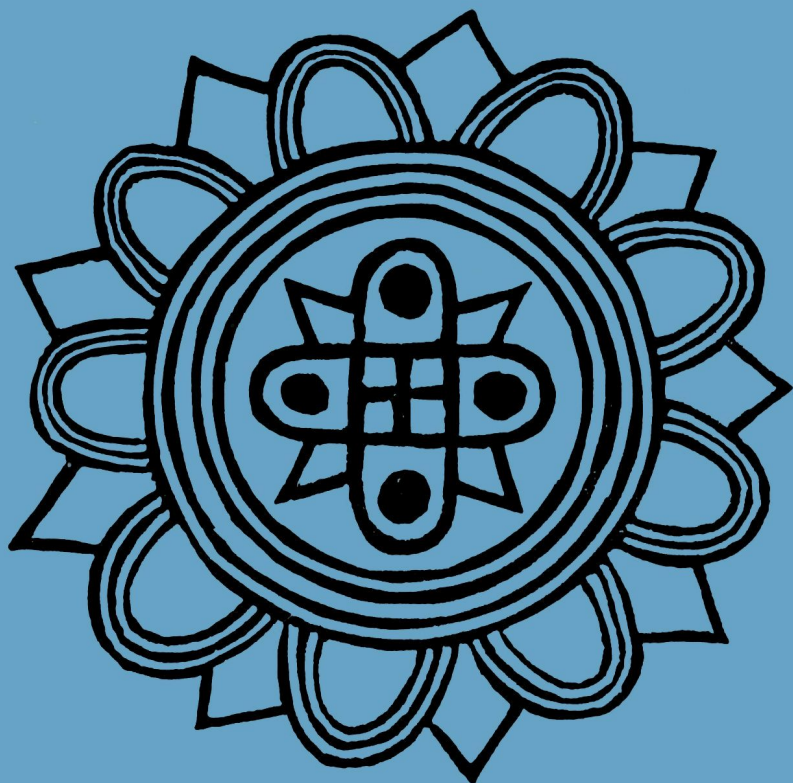

The *Review* will only consider manuscripts that have not been published elsewhere and are not being considered by other journals.

## CONTRIBUTORS

**AIDAN SOUTHALL** is Professor of Anthropology at the University of Wisconsin-Madison and was President of the African Studies Association from 1986 to 1987. He has authored or edited seven volumes and over seventy articles on Africa on topics including urban anthropology and urban ethnicity, social change in modern Africa, and mode of production theory. His most recent publications include *The Segmentary State in Africa and Asia* (1988) and *Mode of Production Theory: The Foraging Mode of Production and the Kinship Mode of Production* (1987).

**ONIGU OTITE** is Professor of Sociology/Social Anthropology at the University of Ibadan, Nigeria. He has authored two books on African social and political thought and has edited four volumes on sociology. His two forthcoming books (1989), *Ethnic Pluralism and Ethnicity in Nigeria* and *On the Path of Progress, A Study of Rural Immigrants and Development in Nigeria*, concern ethnicity and economic development in Nigeria.

**LILLIAN TRAGER** is Associate Professor of Anthropology and Chair of the Department of Sociology at the University of Wisconsin-Parkside. From 1985-87, she was based in Lagos, Nigeria where she was Assistant Representative and Program Officer in the Ford Foundation's West Africa office. **JOHN W. BURTON** is Associate Professor and Chair of the Department of Anthropology at Connecticut College and author of *When the North Winds Blow: Small Towns and Social Transformation in the Southern Sudan*.
