



### Drinking, Homicide, and Rebellion in Colonial Mexican Villages

William B. Taylor. Based on criminal trial records and related documents from central Mexico and Oaxaca, this investigation of three areas of social behavior analyzes how peasants conceived of their role under Spanish rule, how they behaved under stress, and how they felt about their Spanish overlords. In examining the character of village uprisings, typical relationships between killers and their victims, and the drinking patterns of the late colonial period, the author finds no warrant for the familiar picture of sullen depredation and despair.


