This book is an analysis of contemporary Tanzania: *Ujamaa* villages, education for self-reliance, nationalization, and other policies that made Tanzania in the late 1960s the country in Africa most noticeably committed to Socialist policies. But by the end of the 1970s voluntary *ujamaa* villages had been replaced by compulsory 'planned' villages, and the nationalizations had spawned ever-increasing government and parastatal bureaucracies without corresponding increases in production. In this book these policies are interpreted in the light of what came before, in the colonial and pre-colonial periods. It is written for a non-specialist readership, and yet it also includes many insights that will make it compulsive reading for administrators, economists, historians, agriculturalists – indeed almost anyone involved in the process of development. £15 paperback £6.95

For several of these countries the census from which the authors gather their material is the first ever conducted, and therefore much of the national level demographic data used is entirely new.
