## THE CONTRIBUTORS

THOMAS C. SCHELLING is Professor of Economics and a faculty member of the Center for International Affairs at Harvard University. The author of *The Strategy of Conflict* (1960), he is currently working in the fields of military strategy, arms control, and theory of bargaining.

DANIEL LERNER is Ford Professor of Sociology and International Communication in the Department of Economics and Social Science at MIT, and Senior Research Associate in MIT's Center for International Studies. Among his recent books are *The Human Meaning of the Social Sciences* and *Evidence and Inference*, both published in 1959.

RICHARD D. ROBINSON is a staff member of the Harvard Center for Middle Eastern Studies and Lecturer in the Harvard Graduate School of Business Administration. A former Turkish area specialist of the American Universities Field Staff, he is working on a manuscript entitled *The Republic of Turkey: Case Study of Development*.

DAVID E. APTER is Associate Professor of Political Science and Executive Secretary of the Committee for the Comparative Study of New Nations at the University of Chicago. His publications include *The Gold Coast in Transition* (1955) and a forthcoming book, *The Political Kingdom of Uganda: A Study in Bureaucratic Nationalism*.

HERBERT J. SPIRO, Assistant Professor of Government at Harvard, was a recent recipient of a Guggenheim Fellowship, Fulbright Research Professorship, and Social Science Research Fellowship (hon.), to study constitutional politics in the Federation of Rhodesia and Nyasaland and elsewhere in Africa. He is the author of *Government by Constitution: The Political Systems of Democracy* (1959).

S. I. PLOSS, a Soviet affairs analyst, has written an outline of Komsomol history that will appear in 1961.

ABRAHAM S. BECKER, a member of the Economics Division of The RAND Corporation in Santa Monica, Calif., has completed a study of ruble-dollar price ratios for producers' durables, and is engaged in research on Soviet national income in the Seven-Year Plan period.

TALCOTT PARSONS, Professor of Sociology in the Department of Social Relations at Harvard, is the author of *Structure and Process in Modern Societies* (1960) and editor, with E. A. Shils, K. D. Naegle, and J. R. Pitts, of *Theories of Society*, to be published in 1961.

HERBERT McCLOSKEY, former Professor of Political Science at the University of Minnesota, has received a joint appointment in the Department of Political Science and the Survey Research Center at the University of California (Berkeley). He collaborated with John E. Turner on *The Soviet Dictatorship* (1960).

STANLEY HOFFMANN is Associate Professor of Government at Harvard University. The editor of *Contemporary Theory in International Relations* (1960), he is writing a study of French right-wing politics from 1934 to 1944, entitled *The Politics of Defeat*.

ROBERT C. NORTH, Associate Professor of Political Science at Stanford University, is co-director of a Study in International Conflict and Integration and is also engaged in research on Soviet-Chinese relations. His publications include *Moscow and Chinese Communists* (1953) and, with X. J. Eudin, *Soviet Russia and the East, 1920-1927* (1957).

BERNARD C. COHEN, Associate Professor of Political Science at the University of Wisconsin, formerly served as managing editor of *World Politics*. He is the author of *The Political Process and Foreign Policy* (1957) and is writing a book on the press and foreign policy in the United States.
