THE CLASSICAL ASSOCIATION

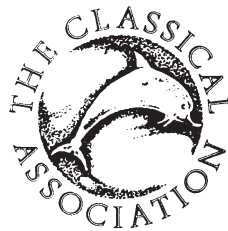
