Each manuscript should be typewritten with wide margins and with double spacing between the lines. Footnotes should be numbered consecutively and should also be typed with wide margins and double spacing, preferably on a separate sheet. Two copies of the manuscript should be sent to the editor, and the author should also keep a complete copy. After the paper is accepted in its final form, an electronic copy in \LaTeX , \AMS-L\TeX , or \AMS-TeX format would be useful. Fifty offprints of each article are supplied at no charge, and additional offprints may be purchased if desired.

The JOURNAL invites submission of (1) original technical papers in the field of symbolic logic, (2) expository papers in this field, (3) papers whose main point is philosophical and which either bear upon logic or make use of its methods, and (4) studies in the history of logic in which modern technical developments are taken into account.
