Zeke Baker is a PhD candidate in sociology at the University of California, Davis. His dissertation "Meteorological Government" investigates the relationships between climate knowledge and government from the late eighteenth century until recent decades, primarily in the US context. He has written widely about Egypt, Iran, Iraq, and South Asia and about the upheavals in the Arab World since 2011, including about Sunni extremist groups and Shiite politics.

Lisa D. Cook is Associate Professor of Economics at Michigan State University, where she is Director of the American Economic Association Summer Training Program and an affiliate of the Center for Venture Capital, Private Equity, and Entrepreneurial Finance and the Center for Russian, European, and Eurasian Studies. She is also a research associate at the National Bureau of Economic Research.

Jonathan Endelman is a PhD graduate (2017) from Yale University in sociology. His publications include "Displaying the State: Visual Signs and Colonial Construction in Jordan" (2015).
