Franz Brentano (1838–1917) exerted an extraordinary influence upon the development of philosophy. His many distinguished pupils included Meinong, Husserl, and Freud, and the present work, Brentano's doctoral dissertation, awakened Heidegger's interest in philosophy. Brentano saw himself as an intimate disciple of Aristotle. In this volume he pursues Aristotle's discussion of the several senses of "being". FRIEDRICH NIETZSCHE AND THE POLITICS OF TRANSFIGURATION

Tracy B. Strong

In his examination of Nietzsche's philosophic doctrines which have implications for political theory, Mr. Strong focuses on Nietzsche's claim that Western culture, in all its aspects, is coming to an end. He first investigates Nietzsche's general view of society and culture, and then examines what Nietzsche called the "politics of virtue". These chapters deal with the structure of language and of Western conceptual patterns, with the structure and nature of moral interactions, and with the source of these problems which Nietzsche saw as inherent in Western morality. The author next provides an extended analysis of Nietzsche's consideration of ancient Greece, followed by an account of Nietzsche's views on specifically political matters. The later part of the volume focuses on two basic Nietzschean concepts: the will to power; and eternal return. Mr. Strong proposes a new understanding of the will to power and attempts to show precisely what its relation might be to a new revaluation of values. He also describes a new conception of the doctrine of eternal return which permits an entirely new appreciation of the question of Nietzsche's so-called "racism" and of his "Lamarckianism".
