## Badger bibliography

The badger has been widely written about as an interesting wild mammal, as a reservoir/victim of bovine tuberculosis infection and as the subject of the cruel and illegal 'sport' of badger baiting. As a consequence, the literature on this species is extensive naturalists, veterinary surgeons, scientists, conservationists and others have published widely in the technical journals and the specialist magazines.

A commendable bibliography has been compiled by Vink which, to a large extent, successfully gathers together in one accessible place much of the literature on this interesting and - from the animal welfare point of view - important species. Most of the listed material is written in English although works in other European languages are included. The entries are classified alphabetically under the authors' names within each of eleven separate sections which, for example, include such titles as 'Population dynamics and home-range utilization' (143 entries) through 'Food and feeding behaviour' (110 entries) and 'Bovine tuberculosis in badgers' (96 entries) to 'Threat and protection' (338 entries). Some entries appear in more than one section. There is no subject or author index and this, in view of the quantity of material listed in some sections may make searches for particular subject items a little tedious. However, the material is there and it is an eye opener, at times, to realize just how much has been published. This bibliography is a most practical and useful guide to the extensive European literature on the badger.

## The Kinship Library - animal welfare classics
