¶ The Newcomen Awards in Business History are presented annually for the best and second-best articles published in the *Business History Review*. First prize is a cash award of \$250.00; second prize a cash award of \$100.00.

¶ Prize articles are selected by a panel of judges composed of a representative of The Newcomen Society and selected members of the Advisory Board of the *Business History Review*. The editor and authors of articles eligible for awards are not members of the judging panel. The awards program is administered by the editorial offices of the magazine.

¶ Criteria for selection include: originality, value, breadth, and interest of contribution, quality of research materials and methods, and quality of presentation.

¶ Presentation of the 1959 awards was made by Charles Penrose, Jr., Senior Vice-President for North America, at The Newcomen Society Massachusetts Dinner on November 5, 1959, at the Hotel Somerset in Boston.
