CONTRIBUTORS

LARAY DENZER is a Scholar-in-Residence in the Ethnic Studies Program at the University of Santa Clara. A historian, her main areas of research are West African anticolonialism and Pan-Africanism. Her most recent publication is "Grass Roots Leadership in Colonial Africa," *Tarikh*, No. 25 (1981), of which she is guest editor and contributor.

BRUCE FETTER is Associate Professor of history at the University of Wisconsin-Milwaukee and editor of *Urbanism Past and Present*.
