CENTRAL AMERICA AND THE CARIBBEAN

The U.S. State Department's formerly confidential diplomatic post files from Central America and the Caribbean for the period from 1930 onward have never been published in any format until now. As the definitive source of American diplomatic reporting from the region, the records in these files are the very best primary sources for the study of the long-term development of U.S. policy toward Central America and the Caribbean and, even more significantly, for the study of the complex mix of social, economic, and political factors that has shaped the current conditions of the region. Therefore, the fact that over 200,000 pages of these records are being published for the first time is important news for professors and students with interests either in the history of U.S. foreign relations or in the history of Central America and the Caribbean. The diplomatic post files from Cuba, Honduras, El Salvador, and Nicaragua form the first installments in what will be an ongoing project to publish the records of key State Department posts throughout Latin America.

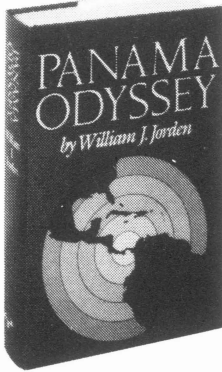

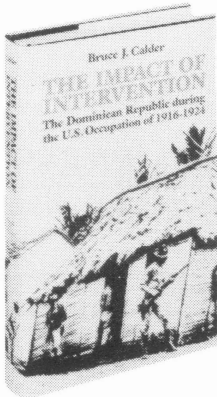

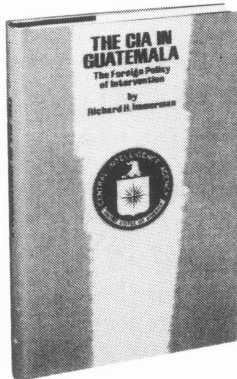

NOTES ON THE CONTRIBUTORS

GREG URBAN is Assistant Professor of Anthropology at the University of Texas at Austin. He has conducted extensive field research among various Brazilian Indian tribes, including two years with the Shokleng tribe. The author of several recent articles, he is currently directing the Native South American Language Project at the University of Texas at Austin.

FRANCINE MASIELLO is Associate Professor of Spanish and Comparative Literature at the University of California, Berkeley. The author of books on Argentine avant-garde literature and numerous studies on modern Spanish American literature, she is preparing a book on Spanish American fiction of the 1920s.

PAUL G. BUCHANAN, a doctoral candidate in Political Science at the University of Chicago, is writing a dissertation on state development and regime change in postwar Argentina. He has written articles on organized labor and nuclear proliferation under military regimes in the Southern Cone.

RODERIC CAMP has written numerous articles and books on Mexico, including two forthcoming works, *The Making of a Government: Political Leaders in Modern Mexico* and *Intellectuals and the State in Twentieth-Century Mexico*. As a fellow at the Wilson Center in 1984, he conducted research on the relationship between the Mexican private sector and the state.

CARLOS M. VILAS is an Argentine social scientist who has been working in Nicaragua since 1980. His *Perfiles de la Revolución Sandinista* was published in Havana, and *La revolución en Nicaragua*, coedited with Richard Harris, will soon be published in Mexico.

MARCELLO CARMAGNANI, Professor of Latin American History at the University of Turin, has also taught in Chile, Mexico, and the United States. The author of publications on the economic and social history of colonial Chile and Mexico, he is currently completing a book on the ethnic revival in eighteenth-century Oaxaca.

MURDO J. MACLEOD is Professor of History at the University of Arizona and has published studies on various aspects of colonial and modern Latin America.

CHERYL E. MARTIN is Assistant Professor of History at the University of Texas at El Paso. Her book, *Rural Society in Colonial Morelos*, will be published in 1985 by the University of New Mexico Press.

JOHN E. KICZA is Associate Professor of History at Washington State University and the author of *Colonial Entrepreneurs: Families and Business in Bourbon Mexico City*. His research interests include urban social history and family history.

DANIEL H. LEVINE is Professor of Political Science at the University of Michigan. His most recent book is *Religion and Politics in Latin America*. His current research concerns the development of base communities and popular organizations.

CAROLYN P. BOYD is Associate Professor of History at the University of Texas at Austin. The author of *Praetorian Politics in Liberal Spain*, she is currently conducting research on history education and history textbooks in twentieth-century Spain.

IVAN JAKSIC is Research Associate and Program Coordinator at the Center for Latin American Studies at the University of California, Berkeley. He is writing a book on philosophy and higher education in Chile.

ROBERT J. KNOWLTON is Professor of History at the University of Wisconsin at Stevens Point. The author of *Church Property and the Mexican Reform, 1856–1910*, he is currently researching the effects of liberal legislation on civil corporate property in nineteenth-century Mexico.

ANN HARTNESS-KANE is Assistant Head Librarian of the Benson Latin American Collection at the University of Texas at Austin. She is the author of *Revolution and Counterrevolution in Guatemala, 1944–1963: An Annotated Bibliography of Materials in the Benson Latin American Collection and Subject Guide to Statistics in the Presidential Reports of the Brazilian Provinces, 1830–1889*.

STEVE ELLNER teaches economic history at the Universidad de Oriente in Puerto La Cruz, Venezuela. He is the author of *Los partidos políticos y su disputa por el control del movimiento sindical en Venezuela, 1936–1948*, published by the Universidad Católica Andrés Bello in 1980.

CHARLES D. AMERINGER is Professor of Latin American History at the Pennsylvania State University. He has published a biography, *Don Pepe: A Political Biography of José Figueres of Costa Rica*, two other books, and numerous articles on modern Caribbean and Central American history.

MARY H. PREUSS is Acting Head of the Department of Foreign Languages at Geneva College, President of the Latin American Indian Literatures Association, and Editor of the *Latin American Indian Literatures Journal*. The author of several articles on Latin American Indian literatures, she is conducting an ongoing research project of taping, transcribing, and translating Yucatec-Maya oral literature.
