THE MEASUREMENT OF INTRAPERSONAL SPACE BY GRID TECHNIQUE Vol. 1, Explorations of Intrapersonal Space and Vol. 2: Dimensions of Intrapersonal Space edited by **Dr. P. Slater**, *St. George's Hospital Medical School, London.*

A man's intrapersonal space, his mental image of the world around him and his own place in it, can be brought within reach of measurement by grid technique. This is a method of interviewing generalised from Kelly's Repertory Grid, Osgood's Semantic Differential, Stephenson's Q technique and other related methods. Volume 1 *Explorations of Intrapersonal Space* presents the first comprehensive collection of studies illustrating the flexibility of the Grid technique and the diversity of the uses to which it can be applied.

Vol. 2 explains what is meant by intrapersonal space, and goes on to describe methods of interviewing that can be used to obtain grids, and suitable methods of mathematical analysis to apply to them. Information is also given on programs for comparing grids and analysing them in pairs and larger sets.

The techniques discussed in the book are described in considerable detail, so as to give the reader as clear an idea as possible of the nature of the projective experience, i.e., what happens when a projective test is administered. A very full account is given of the two major techniques

THE EXPERIENCE OF DEPRESSION

by **Dorothy Rowe**, *Principle Psychologist, Lincolnshire Area Health Authority*

The point that language structures reality rather than reality structures language has been made by philosophers and linguists from Vico and Kant, through von Humboldt to Ernst Cassirer and George Steiner, through C.S. Pierce and Dewey to George Kelly. *Drawing on this and on literary* as well as scientific sources this book argues that a person's behaviour is the outcome of his individual language, which is the fusion of sentences, feelings and images, and by which he creates his world.

Taking as a special case, the behaviour of a person said to be suffering from a depressive illness, the book describes nine individuals and shows how, through their own words, these constructs can be revealed by which each has built the prison which is depression.
