**Precedent in English Law** RUPERT CROSS When the first edition of this book was published in 1961, the English doctrine of precedent had become more rigid than ever before. Now, however, this position has been reversed. The loosening was largely brought about by the famous Practice Direction of the House of Lords of July 1966 in which the House asserted its power to reconsider previous decisions. The author, who is Vinerian Professor of English Law in the University of Oxford, discusses fully the implications of the Direction, together with several other indications of the changing climate in the rules of precedent. He has also attempted to collect together all the exceptions to the rule of stare decisis, although such a collection cannot be regarded as definitive. #### Administrative Law H. W. R. WADE

Since this textbook was first published six years ago there have been important developments in administrative law, much of which is judge-made. The central parts of the book have therefore been extensively rewritten. As before, it attempts to clarify the outlines of a subject which is insufficiently recognized as a single body of law. The principles of judicial control, natural justice, and tribunals and inquiries are given special prominence. The author is Professor of English Law in the University of Oxford.
