It is arranged alphabetically by jurisdiction, and contains annotated citations to constitutions, major codes, official codifications, session laws, court reporters and official gazettes.

Each section has an introduction describing the particular country's legal system and mentioning the major English-language books on the laws of that country.

Each section also includes a subject breakdown of over 50 headings with bibliographic citation to primary sources and translations. This enables the user to determine the operative laws for a particular subject area.

The work is comprehensive in content and global in scope. Volume 1, published in 1989, covers the Western Hemisphere. Volume 2, published in 1991, covers Western and Eastern Europe and the European Communities. Volume 3, published in 1993, covers Africa, Asia and Australasia.

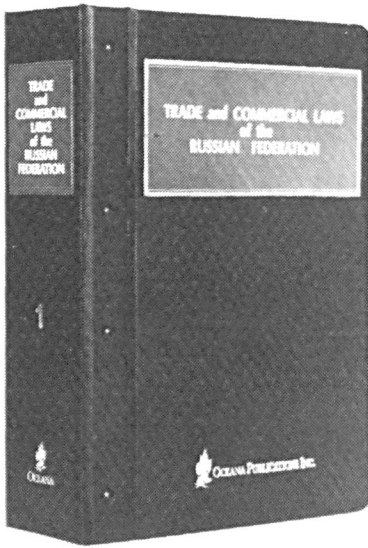
