THE CONTRIBUTORS

GABRIEL A. ALMOND is Professor of Political Science at Stanford University. His recent publications include *The Politics of the Developing Areas*, which he and James S. Coleman edited in 1960, and, with his co-author Sidney Verba, *The Civic Culture: Political Attitudes and Democracy in Five Nations* (1963).

Douglas E. Ashford, Associate Professor of Public and International Affairs, Graduate School of Business and Public Administration, Cornell University, has written widely on political problems in North Africa—most recently, *Perspective of a Moroccan Nationalist* (1964). He is making a comparative study of the role of local government reform in development of Morocco, Tunisia, and Pakistan.

J. Panglaykim is Associate Professor of Business Administration and Director of the Institute for Management in the Faculty of Economics, University of Indonesia, Djakarta. He has written three books in Indonesian on management organization and marketing in selected socialist countries and, in English, State Trading Corporations in Indonesia: First-Year Performance, 1961. He has also served as an advisor to various government departments and committees.

CHALMERS JOHNSON, Assistant Professor of Political Science at the University of California, Berkeley, has recently published *Peasant Nationalism and Communist Power* (1962), *An Instance of Treason: Ozaki Hotsumi and the Sorge Spy Ring* (1964), and *Revolution and the Social System* (1964). He is working on a book entitled *Revolutionary Change* which attempts to conceptualize revolution in terms of political and social theory.

PETER PARET, Associate Professor of History at the University of California, Davis, is the author of French Revolutionary Warfare from Indochina to Algeria (1964) and, with John W. ROBERT W. TUCKER is Professor of Political Science and Director of the International Studies Program at The Johns Hopkins University. Author of *The Just War* (1960), he is currently engaged, with Robert E. Osgood, on a study of the role of force in international politics.

MORTON A. KAPLAN, Associate Professor of Political Science and Chairman of the Committee on International Relations at the University of Chicago, is also a staff member of the Hudson Institute at Harmon-on-Hudson, N.Y. His books include System and Process in International Relations (1957) and, with Nicholas de B. Katzenbach, The Political Foundations of International Law (1961); he edited The Revolution in World Politics (1962).
