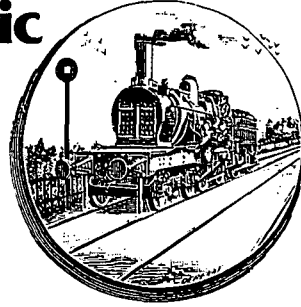

The final chapter suggests conclusions about the emergence of a Europe-centered world economy.
