CONTRIBUTORS

Jeroen Dewulf is Queen Beatrix Professor at the University of California, Berkeley, where he is also director of the Institute of European Studies and the Center for Portuguese Studies. In 2014, he was distinguished with the Hendricks Award of the New Netherland Institute. In 2015, he received the Louisiana History President's Memorial Award and both in 2015 and 2016, he was the recipient of the Van Slyke Article Prize in New Netherland studies. In 2019, his monograph on the Mardi Gras Indians received the Gold Medal Independent Publishers Book Award. His most recent book publications include *The Pinkster King and the King of Kongo* (2017), *From the Kingdom of Kongo to Congo Square* (2017), and *The Congo in Flemish Literature* (with Luc Renders, 2020).

Romina Green Rioja is visiting Assistant Professor of Latin American History at Claremont McKenna College. She received her PhD in history from the University of California, Irvine, in 2018. Her book project *To Govern is to Educate: Modeling Racial Education in Modern Chile (1879–1920)*, examines the emblematic relationship between state education and immigration policies in former native Mapuche territories that resulted in defining Chilean race politics in the twentieth century. Her article “Land and the Language of Race: State Colonization and the Privatization of Indigenous Lands in Araucanía, Chile (1871–1916),” in this issue, was the result of a postdoctoral DICYT fellowship at the Faculty of Administration and Economics of the Universidad de Santiago in Chile, under the supervision of Professor Claudio Robles Ortiz. In addition to her work on nineteenth-century Chile, she researches and publishes on contemporary issues about feminism and gender in Latin America.

Rajeshwari Dutt is Associate Professor at the Indian Institute of Technology, Mandi (India). She holds a PhD in Social and Cultural History from Carnegie Mellon University (2012). Her research interests are in race and imperialism in nineteenth-century Latin America and the Caribbean. She has published journal articles in *The Americas*, *Ethnohistory*, the *Hispanic American Historical Review*, and *World History Connected*. She is the author of two monographs, *Maya Caciques in Early National Yucatán* (2017) and *Empire on Edge: The British Struggle for Order in Belize during Yucatán's Caste War, 1847–1901*

(2020). She is currently working on a monograph on the Nicaraguan canal route in the nineteenth century.

José Carlos de la Puente Luna is Professor of History and director of graduate studies at Texas State University. He is the author of *Los curacas hechiceros de Jauja: batallas mágicas y legales en el Perú colonial* (2007) and *Andean Cosmopolitans: Seeking Justice and Reward at the Spanish Royal Court* (2018). He is working on a book about Indigenous land tenure and customary practices of commoning. His most recent piece on the subject, titled “Of Widows, Furrows, and Seed: New Perspectives on Land and the Colonial Andean Commons,” appears in the *Hispanic American Historical Review*.

Rachael De La Cruz is Assistant Professor of Latin American History at Montana State University, Billings. She earned her PhD in history from the University of California, Irvine. Her research examines how and why each Central American nation-state responded to Salvadoran refugees in the transnational context of the late Cold War. Her publications include the articles “Ciudad Romero: The Salvadoran Refugee Family and Panamanian Statecraft under the Torrijos Regime” (2019) and “No Asylum for the Innocent: Humanitarian Representations of Salvadoran Refugees” (2017). She also serves as co-director of the Women’s and Gender Studies Center at the university.
