The titles of books and journals should be underlined (i.e. t be printed in italics), as should foreign words. Titles of articles should be i single quotation marks.

Notes and references will be printed as footnotes and should be type (double-spacing) on a separate sheet, numbered consecutively. They should be referred to in the text by superscripts. Citations should be as follows:
