History and Society in the Theology of St Augustine R. A. MARKUS

A consideration of how Augustine conceived the purpose of human society and how he related this purpose to his concept of man's ultimate destiny. Dr Markus is particularly concerned with Augustine's reflections on history; on divine providence in historical development; on the function of the state and the nature of political obligation; and on the place of the Church in the secular world.

He relates Augustine's ideas to their contemporary context and to older traditions, and shows which aspects he absorbed from his intellectual environment and which he came to adopt only after much thought. Augustine appears as a thinker who rejected the 'sacralization' of the established order of society. Finally Dr Markus looks at the implications of his 'secular' theology in relation to some of the central problems of modern theology. **75s. net**

The Spirit-Paraclete in the Gospel of John

GEORGE JOHNSTON

This book discusses the rich doctrine of John's Gospel concerning the spirit of God, with special reference to the *paraclete* problem. Attention has been paid to the Jewish antecedents and to John's contemporary situation.

Professor Johnston's thesis is that, for the Evangelist, the spirit-paraclete is the divine energy or power which 'inspires' certain Christians (teachers, prophets and martyrs) who act as God's *representatives* or *spokesmen* (paracletes); and that the Church itself as a community of disciplines can be the embodiment of the paraclete. **75s. net**

Johannine Christology and the Early Church

T. E. POLLARD

The author argues that of all New Testament writings it was the Fourth Gospel which set for the Church in the succeeding centuries the theological problems which resulted in the classical formulation of the doctrines of the Trinity and of the divine humanity of Christ. In this process a number of distinct traditions of Christology developed, based on different understandings and methods of interpretation of John's Gospel, which eventually came into collision over the views of Arius and Marcellus.

Professor Pollard contends that the Christology which emerged was that which remained most faithful to the original witness of John. **£6 net**
