CONTRIBUTORS

BARRY M. HALLEN is a Fellow of the W.E.B. Du Bois Institute, Harvard University. Previously he was director of a UNESCO interdisciplinary African research project and Reader in Philosophy at Obafemi Awolowo University (formerly University of Ife), Nigeria.

ABDULLAHI ALI IBRAHIM is an Assistant Professor of History at the University of Missouri-Columbia. He is the author of *Al-Sira' bayn al-Mahdi wal'Ulama (Mahdi/Ulema Conflict in Sudan)* (Khartoum 1968; Cairo 1994); *Assaulting with Words: Popular Discourses and the Bridle of Shari'ah* (Northwestern University Press, 1994) and *Al-Thaqafah wa al-Dimiqrattiyyah (Culture and Democracy in Sudan)* (Cairo 1996). He has written on issues of identity, culture and social history in Sudan, for *History in Africa*, *International Journal of African Historical Studies* and *Northeast African Studies*. This article is an introductory part of his current research which addresses the virulent Islamic revival in Sudan with reference to the colonial Civil/Shari'ah dichotomy in the Sudanese Judiciary.

JEFFREY MEEKER is a Ph.D. candidate in sociology and demography at the Pennsylvania State University. His main research interests focus on the link between different cultures of family planning and fertility declines in developing countries.

His research focuses on sexual initiation and union formation in sub-Saharan Africa and on the impact of social marketing interventions on health behavior.

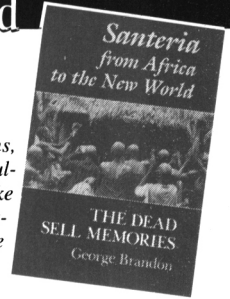
