DOMENICO SCANDELLA KNOWN AS MENOCCHIO

His Trials before the Inquisition (1583–1599)

ed. by **Andrea Del Col** tr. **John & Anne C. Tedeschi**

These trials were the sources of the well-known studies of the relations between popular and learned cultures by Carlo Ginzburg. For his magisterial introduction, Del Col makes use of new documents and offers new interpretations. He explains how the Holy Office in Friuli really functioned, the different ways in which the judges operated and made inquiries, the ways in which the notaries laid down the records—all crucial elements for a correct understanding of the sources. Furthermore, he shows how Menocchio's ideas can be interpreted as a continuation of certain Cathar concepts from the late Middle Ages. Diverging from Ginzburg, this interpretation implies difficult problems of oral transmission, and of alteration and circulation of ideas, setting forth differently the fundamental issue of relations between cultures in European history. The transcripts themselves make fascinating reading.

Petrarch's *Canzoniere* is a central document in the development of the sensibility and the literature of western culture. It marked the intellectual and cultural dividing line between the Middle Ages and the Renaissance. In this body of poetry, a kind of literary autobiography, Petrarch adumbrated the modern mind.

James Wyatt Cook's *Songbook* addresses a remarkable array of poetic elements, including the deceptive simplicity of Petrarch's vocabulary; the cultural context of the work—rendered here as broadly modern rather than facetiously archaic; and the elegance of Petrarch's poetic diction. Because the poetry of Cook's translation reflects Petrarch's poetic creations in carefully considered ways, this volume presents the original Italian text and English verse translation on facing pages. 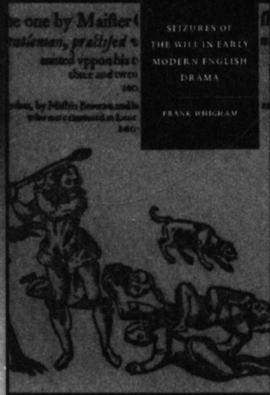

PAOLO GIOVIO

The Historian and the Crisis of
Sixteenth-Century Italy

T. C. Price Zimmermann

Best-known for his sweeping narrative *Histories of His Own Times* and for his portrait museum on Lake Como, the Italian bishop and historian Paolo Giovio (1486–1552) reflects almost the entire spectrum of High Renaissance civilization. In a biography surveying both Giovio's life and his works, T. C. Price Zimmermann examines the historian as a figure formed by fifteenth-century humanism who was caught in the changing temper of the Counter Reformation.

Roman baroque sculpture is usually thought of in terms of large-scale statues, tombs, or portrait busts. Smaller bronze statuettes are overlooked, and the extensive production of sculptural silver—much of which is now lost but can be studied from drawings—is omitted from the histories of art. In these lectures, Jennifer Montagu enriches our understanding of the sculpture of the period by investigating these works.

The book concentrates on selected pieces by such master sculptors as Bernini, and leading metal-workers such as Giovanni Giardini. Montagu examines the often tortuous relationship between patrons and artists and elucidates the relationship between those who provided the drawings or models and the craftsmen who executed the finished sculptures.

NICOLAS POUSSIN

Friendship and the Love of Painting
**Elizabeth Cropper
and Charles Dempsey**

By investigating the important cultural figures who were close to the painter Nicolas Poussin (1594–1665), Elizabeth Cropper and Charles Dempsey allow the reader to enter not only the Rome where he lived but also the Rome of antiquity, which he admired and tried to reconstruct. The authors argue that Poussin's works were structured by his friendships, as well as by his study of ancient history and early Christian archaeology, his exploration of the poetry and mystery of ancient places, and his conception of his paintings as gifts rather than commercial objects.

By looking into this rich background, they also show how Poussin introduced into his theory and practice of painting a new concept of the inherent expressiveness of form that was quite different from the then prevailing conventions for depicting the passions and affections.

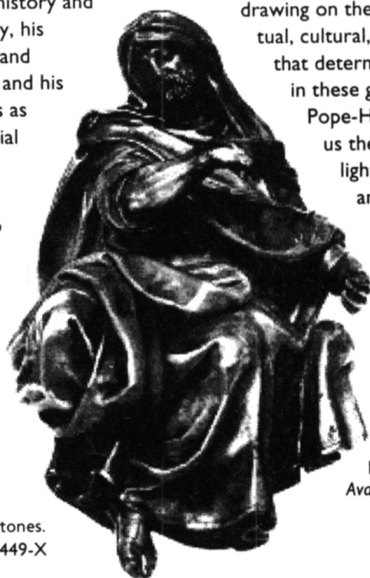
