Gregor Benton and Alan Hunter provide here a source book of documents of democratic dissent under Chinese Communism, most of them previously untranslated and difficult to find in the West. Ranging from eye-witness accounts of a massacre to theoretical critiques of Chinese Marxist thought, these essays are among the most powerful and important works of Chinese dissident literature written in this century.

Alastair Iain Johnston

Cultural Realism is an in-depth study of premodern Chinese strategic thought that has important implications for contemporary international relations theory. In applying a Western theoretical debate to China, lain Johnston advances rigorous procedures for testing for the existence and influence of "strategic culture."

Johnston sets out to answer two empirical questions. Is there a substantively consistent and temporally persistent Chinese strategic culture? If so, to what extent has it influenced China's approaches to security? The focus of his study is the Ming dynasty's grand strategy against the Mongols (1368–1644). The findings of this book challenge dominant interpretations of traditional Chinese strategic thought.





CHINA

In 1978 China was economically and politically exhausted. By 1994, after one of the most successful examples of economic reform ever witnessed, the country has emerged as a major force in the world economy. This issue of the *Oxford Review of Economic Policy* takes a succinct look at all the important elements in the continuing reform process and attempts on that basis to evaluate China's economic prospects. Contributions examine:



- what is happening to the governance and performance of China's large state-owned enterprises and the prospects of reform to reduce or eliminate losses.
- the closely related questions of how reform of the financial system is proceeding and whether this can deliver both monetary control and efficient integration with the industrial sector.
- the consequences and prospects for China's exchange-rate regime and trade capital flows with the rest of the world.

Inextricably linked to these are a number of other issues which have received rather less attention in the West, but which are crucial to a full understanding of China's position. These include:

- China's rural development, in agriculture but also in industrial development through Township and Village enterprises.
- China's labour problems and the obstacle to development of a social security system and housing reform.
- China's chronic problems in the energy sector and in developing the human capital necessary to maintain the country's growth performance.

Overlapping many of these issues is that of growing regional disparities and regional fragmentation, and the increasing inability of the central authorities to tackle the inequalities which these are causing. Also addressed are the overall implications for macroeconomic stability and stabilisation policy, for economic growth and for the process of reform itself.




