ERRATA

The site locations on maps published in Hayden and Schulting's article "The Plateau Interaction Sphere and Late Prehistoric Cultural Complexity" (Vol. 62, No. 1, pp. 51–85) mistakenly place Neah Bay (site 100) on the Columbia River, whereas it should be located on the tip of the Olympic Peninsula; and Ksunku (site 103) is mislocated about 50 km downstream from its actual location in the vicinity of site 41.

On page 72, the reference to point fragments in two dogs and the backs of all dogs being broken at Wildcat Canyon was erroneously attributed to Dumond and Minor (1983), whereas it should have been attributed to L. S. Cressman and D. Cole's 1962 work: Interim Report, 1961–1962, Contract No. 14-10-0434-481 (John Dasy Reservoir-FY 1961). Report to the National Park Service, Region Four, July 15, 1962. 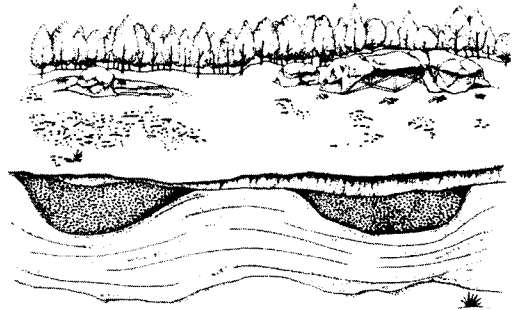

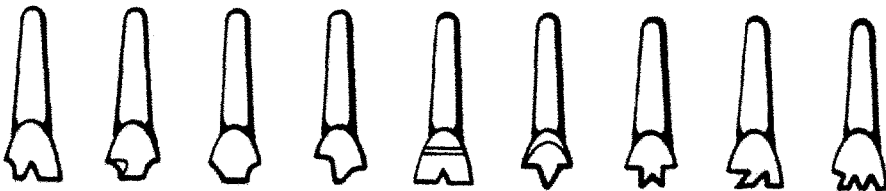
BONES OF THE MAYA

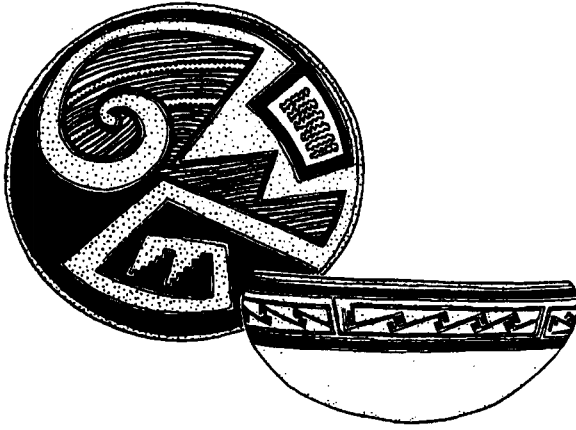


Romer's system of classification for artificially modified teeth.

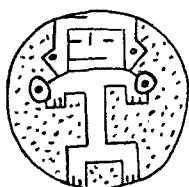

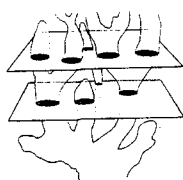
