It contains refereed papers describing the results of research that elucidates the nature of phenomena relating to all aspects of weeds and their control. It is published quarterly, one volume per year, four issues per year beginning in January.

Membership is \$60 per year, student affiliate membership \$20, which includes receipt of *Weed Science*, *Weed Technology*, and *WSSA Newsletter*. Dues should be sent to WSSA, 309 West Clark Street, Champaign, IL 61820 not later than December 1 of each year. Membership in the society is on a calendar-year basis only.

Subscriptions (institutions, libraries, etc.) are \$100 per year, one volume per year of four issues beginning in January. New subscriptions and renewals begin with the first issue of the current volume and should be sent to WSSA, 309 West Clark Street, Champaign, IL 61820.
