The movement of workers from one country to another, whether as migrants or because their job requires them to travel, and the operations of companies in countries other than those in which they were established, are matters that raise questions regarding the law to be applied to individual and collective labour relations. To what extent can the parties themselves decide between laws? What are the general rules applicable to the issues, etc? In this comparative survey the author analyses the approaches to such questions under various legal systems and illustrates the practical implications. The points of particular difficulty become apparent and the best courses to follow are discussed in a brief conclusion.
