Clegg establishes the nature and source of the controls, and evaluates their means and effectiveness. By considering the literary and bibliographical evidence of books that were censored, and placing them in the literary, religious, economic and political culture of the time, Clegg concludes that press control was neither a routine nor a consistent mechanism.

This ability to resist tendentious appropriations and reductive readings helps explain the continuing critical fascination with this most enigmatic of writers.

Recent explanations of changes in early modern European thought speak of a move from orality and emphasis on language to print culture and a "spatial" way of thinking. Reiss describes how, while teaching and public debate continued to be based in the language arts, scientific and artistic areas came to depend on mathematical disciplines, including music, for new means and methods of discovery, and as a basis for wider sociocultural renewal.

Through new research into the reception of Chaucer's *Troilus and Criseyde*, this study of the origins of courtly literature reveals the culture of spectatorship and voyeurism that shaped early Tudor English literary life and demonstrates how Pandarus became the model of the early modern courtier. In close readings of early Tudor poetry, court drama, letters, manuscript anthologies and printed books, Lerer illuminates a "Pandaric" world of displayed bodies, surreptitious letters, and transgressive performances.

Defining the Renaissance "Virtuosa" considers the language of art in relationship to the issues of gender difference through an examination of art criticism written between 1550 and 1800 on approximately forty women artists who were active in Renaissance Italy. Fredrika Jacobs demonstrates how these theoretical writings defined women artists, by linking artistic creation and biological procreation. Jacobs' study shows how deeply the biases of these early critics have inflected both subsequent reception of these Renaissance virtuose, as well as modern scholarship.

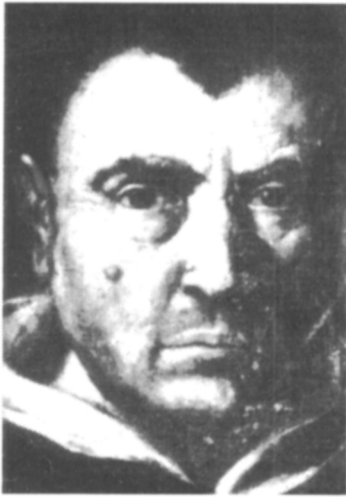

The erotic frescoes adorning a chamber in San Gimignano’s communal bell tower are among the most fascinating surviving examples of secular art from the late Middle Ages. Despite their fame, neither these frescoes nor those of the commune council hall have been well understood as products of the communal culture they represent. Here Jean Campbell explores the sources and significance of the images on these walls by constructing an interdisciplinary microhistory of an early Italian commune. Her investigation addresses notions of nobility, personal display, and public space, describing how the game of courting colored urban life in the age of Dante.

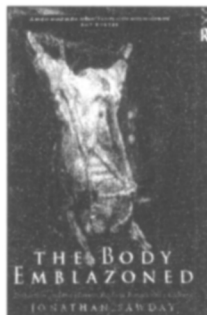
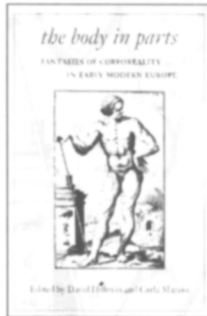

The Phyllis Goodhart Gordan Book Prize

The Renaissance Society of America awards an annual book prize of \$1,000 in memory of the late Phyllis Goodhart Gordan, a strong supporter of the RSA from its early days. The purpose of the prize is to recognize significant accomplishment in Renaissance Studies by members of the RSA and to encourage Renaissance scholarship, the goals of the RSA since its foundation in 1954.

The Gordan Prize will be awarded to the author of the best book in Renaissance Studies published between July 1 and June 30 of the succeeding year. The winner is announced at the Annual Meeting of the Society.

To be eligible, a book must be written by a current member of the RSA; it must be written in English; and it must be in one of the disciplines recognized by the RSA. Please see the inside cover of the *Directory of Members of the RSA* or an issue of *RQ* for the list of disciplines. The prize will be awarded for a book dealing with a Renaissance topic within the chronological period, 1300-1700. The following are offered as examples of Renaissance topics: a vernacular or Neo-Latin literary author, topic, or text; humanism in any of its forms; printing; a Renaissance city-state and/or its institutions; the art or an artist of the period. These topics are not meant to exclude other possibilities. Bibliographical works and scholarly aids are eligible for the Gordan Prize, but editions of texts and translations into English will not be considered.

Books will be judged on the following criteria: a) Contribution to Renaissance Studies; b) Originality in insight and research; c) Clarity and eloquence; d) Thoroughness and accuracy in documentation.

One copy of each work, together with a brief curriculum vitae, must be received by *each* of the prize committee members. Each entry should be labeled "Gordan Prize Entry." *Entries must be postmarked by or on July 15 to be eligible.* Late entries will not be considered. Contact the RSA office for names and addresses of committee members.
