JENNIFER ALLEN is an assistant professor of modern European history at Yale University (Department of History, 1037 Chapel Street, P.O. Box 208324, New Haven, CT 06520-8324; email: j.allen@yale.edu). She is currently completing a book titled “Sustainable Utopias: Art, Political Culture, and Historical Practice in Late Twentieth-Century Germany,” which charts Germany’s postwar efforts to revitalize the concept of utopia. Allen’s other research focuses on counterculture and grassroots activism in the twentieth century, the cultural politics of Cold War and post-Cold War Europe, and the theories and practices of memory in modern Europe.

FRANK BIESS is professor of history at the University of California-San Diego (Department of History, 9500 Gilman Drive, La Jolla, CA 92093-0104; email: fbieess@ucsd.edu). He is the author of *Homecomings: Returning POWs and the Legacies of Defeat in Postwar Germany* (2006) and the coeditor of several volumes, most recently (with Hartmut Berghoff and Ulrike Strasser) of *Explorations and Entanglements: Germans in Pacific Worlds from the Early Modern Period to World War I* (2018). His new book, *Republik der Angst. Eine andere Geschichte der Bundesrepublik*, was published in 2019; an English edition will appear as well. He has held numerous fellowships, most recently a fellowship from the National Endowment for the Humanities in 2017-2018.

NOEL D. CARY is professor of history at the College of the Holy Cross (Department of History, College of the Holy Cross, 1 College Street, Worcester, MA 01610; email: ncary@holycross.edu). He has published numerous scholarly articles on the Munich Olympics of 1972, West German foreign policy, reunification, and civic culture in Weimar and Nazi Germany. He has also published two articles on astrophysics, and is a classical and jazz musician. He is the author of *The Path to Christian Democracy: German Catholics and the Party System from Windthorst to Adenauer* (1996).

ASTRID M. ECKERT is associate professor of history at Emory University (Department of History, 561 S. Kilgo Circle, Atlanta, GA 30322; email: aeckert@emory.edu). Her book *The Struggle for the Files: The Western Allies and the Return of German Archives after the Second World War* (2012) won the 2013 Waldo Gifford Leland Award by the Society of American Archivists. Her forthcoming book, *West Germany and the Iron Curtain*, explores the consequences of the Iron Curtain for West Germany in economic, environmental, and political terms. She has held several prestigious fellowships, including the Berlin Prize Fellowship at the American Academy in Berlin and a Humboldt Research Fellowship.

JOACHIM C. HÄBERLEN is associate professor of modern Continental European history at the University of Warwick (Department of History, University of Warwick, Humanities Building,

University Road, Coventry, CV4 7AL, UK; email: j.haeberlen@warwick.ac.uk). He is author of *The Emotional Politics of the Alternative Left: West Germany, 1968-1984* (2018), *Wie aus Fremden Freunde werden: Ein politisches Essay über Begegnungen mit Flüchtlingen* (2018), and *Vertrauen und Politik im Alltag: Die Arbeiterbewegung in Leipzig und Lyon im Moment der Krise, 1929-1933/38*; as well as coeditor, with Mark Keck-Szajbel and Kate Mahoney, of *The Politics of Authenticity: Countercultures and Radical Movements Across the Iron Curtain, 1968-1989* (2018). In addition, he has published numerous articles in journals such as *Contemporary European History*, *The Journal for the History of Sexuality*, and *Geschichte und Gesellschaft*. He is currently embarking on a new project on “refugee stories.”

KARRIN HANSHEW is associate professor of history at Michigan State University (Department of History, Old Horticulture, Room 331, 506 E. Circle Drive, East Lansing, MI 48824; email: hanshew@msu.edu). She is the author of *Terror and Democracy in West Germany* (2012) and, with Peter C. Caldwell, of *Germany Since 1945: Politics, Culture, Society* (2018). Currently she is working on a book titled “A European Affair? German and Italian Entanglements after World War Two.”

CHRISTINA VON HODENBERG is professor of history at Queen Mary University of London and director of the German Historical Institute London (17 Bloomsbury Square, London WC1A 2 NJ, UK; email: c.hodenberg@ghil.ac.uk). She is the author of five books, most recently *Television's Moment: Sitcom Audiences and the Sixties Cultural Revolution* (2015) and *Das andere Achtundsechzig: Gesellschaftsgeschichte einer Revolte* (2018). She won a Humboldt Research Award in 2014.

CAITLIN E. MURDOCK is professor of history at California State University, Long Beach (Department of History 1250 Bellflower Blvd, Long Beach CA 90840; email: c.murdock@csulb.edu). She is also an honorary research associate of the Graduate School for East and Southeast European Studies at the University of Regensburg. Murdock is the author of *Changing Places: Society, Culture, and Territory in the Saxon-Bohemian Borderlands, 1870-1946* (2010), as well as of numerous articles. Her current book project, “Radiant Health: Radiation Exposure and the Politics of Public Health in Twentieth-Century Central Europe,” explores popular, scientific, and political debates about the risks and benefits of nuclear radiation for human health.

LAUREN STOKES is assistant professor of history at Northwestern University (Harris Hall, 1881 Sheridan Road, Evanston, IL, 60208; email: lauren.stokes@northwestern.edu). She is currently working on her first monograph, which examines the migration category of “family reunification,” with reference to guest workers in the Federal Republic. She teaches widely in German and European history, migration history, and the history of gender and sexuality. Her work has been supported by organizations such as the Alexander von Humboldt Foundation, the Council on European Studies, and the Central European History Society.

Central European History publishes articles, review essays, and book reviews that range widely through the history of Germany, Austria, and other German-speaking regions of Central Europe from the medieval era to the present. All topics and approaches to history are welcome: cultural, social, political, diplomatic, intellectual, economic, and military history, as well as historiography and methodology. Contributions that treat new fields, such as post-1945 and post-1989 history, maturing fields such as gender history, and less-represented fields such as medieval history and the history of the Habsburg lands are especially desired. The journal thus aims to be the primary venue for scholarly exchange and debate among scholars of the history of Central Europe. Because space is limited, articles that have been or soon will be published elsewhere are not accepted. Manuscripts submitted to CEH should not be under consideration by another journal pending decision of the editor on publication. If it is learned that an article is under submission to another journal while being considered at CEH, consideration will cease immediately. Unsolicited book reviews are not accepted.

The editor prefers that manuscripts be submitted via ScholarOne (<https://mc.manuscriptcentral.com/ccc>). Please take care to remove author identifying information, following the prompts in ScholarOne, to make your manuscript anonymous. The entire text of all manuscripts, including endnotes and headings, must be prepared in double-spaced typescript with generous margins to allow for copyediting. Endnotes must be numbered consecutively and should be placed in a separate section at the end of the text.
