the human context

Seven years ago this summer *The Human Context* first saw the light of day; in a sense it was an illegitimate birth: the journal was not the progeny of established groups whose institutional interests it was to represent and protect. It was free from formal and informal group ties, from the prescriptions of schools of thought or doctrines. It professed partisanship for a philosophy of human experience, phenomenology, but without any strings attached to participation.

Surrounded by the still dominating traditions of British Empiricism, *The Human Context* took the view, as Whitehead did before, that the overemphasis on "clear and distinct ideas" had more to do with the survival of Puritan Ethics in language and imagination than with the answers of a self-assured pure empiricism. Independence and the total absence of any corporate power influence was and remains the aim to the end. There was, of course, a lesson to be learnt. Independence did nothing to blunt the edge of competitive pressures and individual freedom often meant a struggle with isolation. Problems such as these frequently played havoc with thematic planning, team-work and the wider programmatic discourse.

The Human Context has tried to explore the philosophical assumptions and the methodology of the human sciences (the different fields of psychology, sociology and anthropology); it has aimed at a critical dialogue between different orientations in philosophy itself and at a confrontation with science. The journal's editorial board comprised authorities in their respective fields in universities in the United Kingdom, the United States of America, France, Germany and other countries, as well as independent authors of the younger generation. Particular attention was paid to movements not yet established by majority traditions in the English speaking world — such as modern phenomenology — or those of contemporary or widely expanding schools which originated on the Continent. The journal published conference reports and the documentation of direct personal experience. It also had an extensive book review section. Among some of its more notable contributors were: Roger Bastide, Basil Bernstein, Alex Comfort, Amitai Etzioni, Henri Ey, Marjorie Grene, Georges Gurvitch, Ervin Laszlo, Maurice Merleau-Ponty, Arnold Metzger, Jacques Monod, Jean Piaget, Paul Roazen, Nathan Rotenstreich, Jean-Paul Sartre...

With the next issue (VII/3 Autumn 1975) *The Human Context* must cease publication. We write this with sadness particularly since *The Human Context* met with more acknowledgement, approval and encouragement than could be expected. Inflation, however is a respecter of none and it has become impossible to continue. Throughout the seven years of its existence Paul Senft has been the journal's Editor and guide. His failing health has regrettably coincided with the end of *The Human Context*.

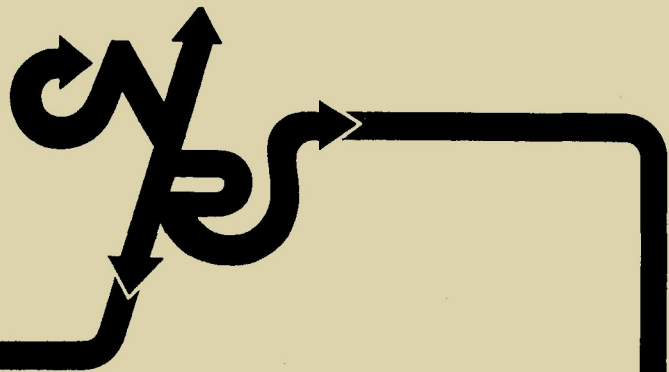
