

Thought Control in Prewar Japan

Richard H. Mitchell

A dark chapter in Japan's recent history receives its first full-scale treatment in this

absorbing work.

How repressive was the prewar Japanese state in its imposition of thought control? Was its treatment of offenders unique? What are the similarities between its thoughtcontrol practices and those in Nazi Germany, Stalinist Russia, and Maoist China? These are some of the questions the author explores as he examines techniques used by the Japanese government before World War II to control thinking it considered dangerous.

Mr. Mitchell reviews the government's attitude toward subversives between 1868 and the 1940's and discusses the Peace Preservation Law of 1925 and the elaborate system of thought control built upon it. He reassesses the role of justice officials, police, and others who made it their duty to stamp out "unhealthy" thoughts, and he analyzes against the Japanese sociocultural background the special methods they developed for handling ideological offenders.

Indonesian Foreign Policy and the Dilemma of Dependence

From Sukarno to Soeharto

Franklin B. Weinstein

The complex interactions between domestic political factors and the shaping of foreign policy are explored in this important work. To discover the ways in which underdevelopment has affected Indonesia's international participation, Mr. Weinstein probes systematically and in depth the view of the world held by Indonesia's elite, and he seeks out the sources of their perceptions. At the same time, he offers an illuminating comparison between the basis of Sukarno's foreign policy and Soeharto's, showing dramatic changes and surprising continuities.

Political Culture and Cultural Politics

Donald K. Emmerson

The first full-length study of Indonesia's bureaucratic and political elite, this ambitious book focuses on the way in which that country's numerous ethnic and religious communities have responded to attempts at modernization. Mr. Emmerson conducted more than 2,000 interviews, and throughout the book he rounds out his quantitative data with biographical, historical, and social detail. His main finding is that it is not the specific beliefs of elite political groups that pose barriers to modernization but rather the conflicts arising out of the distribution of these elites in Indonesian political institutions. An unusual contribution to the study of culture and politics in the Third World, his book will also be read for its sophisticated method and approach.

This study, which grew out of a major World Bank project, provides a concise but wide-ranging review of the energy sector in India as a whole. It includes all the main forms of energy: coal; petroleum; electric power from hydro, thermal, and nuclear sources; and the non-commercial fuels which are still important in India. £3.25

In analysing this situation the author forsakes detailed description of a single local community and instead identifies a set of basic social categories and examines their interaction, as well as the ways in which this, and the categories themselves, have changed in the course of time. £4.50

The subject of this book is the pursuit of wealth by Englishmen in Bengal. 
