

meeting, and he had much pleasure in proposing that this should be done. (Applause.)

The Association had had the privilege of holding their meetings in the Municipal Buildings through the kindness of the Provost and Magistrates of the Town Council of Stirling. They had been very comfortably housed, as would be generally agreed, and the civic authorities of Stirling deserved their gratitude. (Applause.)

Thanks were also due to the Joint Committee of the Stirling District Mental Hospital who entertained the Association to lunch, and to the Directors of the Royal Scottish National Institution, and Dr. Clarkson, Medical Superintendent, who had very kindly entertained members to a Garden Party.

The Stirling County Council had entertained them to an excellent lunch, and finally they had to thank the Glasgow Corporation for kindly placing at their disposal motor launches for the sail on Loch Katrine, which was so thoroughly enjoyed. (Applause.)

Dr. M. ABDY COLLINS desired, as an unofficial member, to second these votes of thanks; and also to call attention to important omissions. One of the latter was an acknowledgment of the hospitality which members had received from the President and Mrs. Campbell. (Applause.) Then there was the invitation for to-day from the Scottish Division, and also the personal hospitality which the members of that Division had pressed upon them. Not all the members in Stirling were present that morning, not because they did not appreciate the hospitality which had been offered, but because some had appreciated it too much! In addition the members were about to be the guests of Sir Iain Colquhoun. He hoped the resolutions would be amended accordingly. (Applause.)

Dr. R. MARY BARCLAY supplemented this expression on behalf of the ladies present.

The PRESIDENT cordially expressed Mrs. Campbell's and his own appreciation of the kind words which had been used in thanking them for all they had done to ensure the success of the meeting. He could assure them that it had been a pleasant duty, and it was made all the more pleasant now because everyone had been kind enough to say how much they had appreciated the arrangements which had been made. It would be a lasting pleasure to Mrs. Campbell and himself to realize that the Annual Meeting held in Stirling had been so successful, and so much enjoyed by everyone.

He would like to take this opportunity to express his grateful thanks to Dr. Buchanan, Divisional Secretary, for his valuable assistance in connection with all the arrangements for the meeting.

The votes were carried by acclamation and the meeting terminated.

Re-opening of the Library.

The Library has now been re-opened at 11, Chandos Street. The Library hours are 10 a.m. to 6.30 p.m.; Saturdays, 10 a.m. to 1 p.m.

The Hon. Librarian will endeavour to obtain, as far as possible, any books on psychiatry and allied subjects required by members.

The following are the conditions under which books may be borrowed

1. Books shall only be lent to a member within the United Kingdom or the Irish Free State who is not in arrears with his subscription.
2. No member may borrow from the Library more than three volumes at one time.
3. Members are liable for cost of carriage on books sent by post, and are responsible for the books from the time they leave the Library until they are received back.
4. Books damaged or lost while in possession of a member will be repaired at his expense or must be replaced by him.
5. A member borrowing a book or periodical from the Library shall be required to sign and return to the Librarian a form of receipt for the same, which will be regarded as an acceptance of these Regulations.
6. A member shall be entitled to retain a book or periodical borrowed from the Library for a period of twenty-eight days, unless the book is required by another member, in which case it can be recalled by the Librarian at the expiration of fourteen days.
7. In the event of a member failing to return any book or periodical within seven days after receiving notice from the Librarian (on the expiration of the period referred to in Rule 6), the Library Committee shall be at liberty to purchase another copy at the expense of such member, and the member shall not be allowed to borrow any other book until the sum thus expended be paid.
