PIONEERS AND PROFITS

PIONEERS AND PROFITS is a study of the extent of frontier land speculation and profitability in Iowa, the heartland state.

The author, working from government land entry and resale records of 53 central counties, has created a study of the Iowa land rush days that saw some 200,000 people settled on its prairies in less than 20 years.

His is the first historical look at the economics of the land boom transactions in the midwest arena. Dr. Swierenga's PIONEERS AND PROFITS examines in detail the impact of Congressional legislation, land office policies, fluctuations of the business cycle, the use (and misuse) of land warrants, time-entry systems.

Illustrations include land warrants, photographs of some of the people prominent in speculation, and graphs that show the spread of settlement up the rivers and out onto the empty prairies.
